Motion was made by Rickertsen and seconded by Salem to utilize the budget document as an audit waiver of the 2012-2013 budget due to minimal activity. Aye: Miller, Hagan, Roberts, Salem, Rickertsen, Stewart. Nay: None. Motion carried.

Assistant City Manager Dennis Burnside reviewed the financial report. The RTSD fund balance is \$181,346.01. Motion was made by Hagan and seconded by Miller to accept the financial report as presented. Aye: Salem, Rickertsen, Roberts, Miller, Hagan, Stewart. Nay: None. Motion carried

Burnside reported that an open house for the preliminary designs on the East Viaduct project will be conducted in October, pending consultant scheduling.
