A regular meeting of the Railroad Transportation Safety District was held on Wednesday, September 14, 2016, at 5:00 p.m., in the Lexington City Council Chambers, at 406 E. 7<sup>th</sup> Street, Lexington, Nebraska. Notice of the meeting was given in advance by publication in the Lexington Clipper Herald; a copy of the Proof of Publication is on file in the office of the County Clerk. Availability of the agenda was communicated in the publish notice and in the notice to member of the RTSD Board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Member of the Board of Directors present were John Salem, Everett Hagan, Dennis Rickertsen, Jeremy Roberts and Bill Stewart. Linda Miller was absent. Chairman Salem opened the public hearing at 5:05 p.m., for the purpose of hearing support, opposition, criticism, or suggestions relating to the proposed FY 2017 RTSD budget. Requested tax amount is \$249,051.00. Alan Rickertsen, Cozad appeared and addressed his concerns ab out the RTSD spending. Chairman Salem closed the public hearing at 5:18 p.m. Motion was made by Hagan and seconded by Stewart to approve Resolution #2016-02; approve FY 2017 budget. Aye: Rickertsen, Hagan, Salem, Stewart. Nay: None. Absent: Miller and Roberts. Motion carried.

Motion was made by Rickertsen and seconded by Stewart to request an audit waiver for FY 2016 budget. Aye: Salem, Hagan, Rickertsen, Stewart. Nay: None. Absent: Miller, Roberts. Motion carried.

Motion was made by Stewart and seconded by Roberts to increase the base of restricted funds by an additional one-percent (1%). Aye: Stewart, Hagan, Rickertsen, Roberts, Salem. Nay: None. Absent: Miller. Motion carried.

The financial report was presented.
