

RAILROAD TRANSPORTATION SAFETY DISTRICT

A regular meeting of the Railroad Transportation Safety District was held on Wednesday, June 20, 2018, at 5:00 p.m., in the Lexington City Council Chambers, at 406 E. 7th Street, Lexington, Nebraska. Notice of the meeting was given in advance by publication in the Lexington Clipper Herald; a copy of the Proof of Publication is on file in the office of the County Clerk. Availability of the agenda was communicated in the publish notice and in the notice to member of the RTSD Board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Member of the Board of Directors present were John Salem, Everett Hagan, Dennis Rickertsen, John Fagot, Jeremy Roberts, and Bill Stewart. RTSD Director Joe Pepplitsch was present.

President Salem called the meeting to order at 5:00 p.m. and announced that the current open meetings act was posted for the public and the location of the poster.

No person appeared at the time scheduled for Citizen's comments.

Motion was made by Hagan and seconded by Stewart to approve the September 13, 2017 regular meeting minutes. Aye: Rickertsen, Hagan, Salem, Fagot, Roberts, Stewart. Nay: None. Motion carried.

Motion was made by Roberts and seconded by Fagot to approve the claims as presented. Aye: Rickertsen, Hagan, Fagot, Roberts, Salem, Stewart. Nay: None. Motion carried.

Motion was made by Stewart and seconded by Rickertsen to elect John Salem as President and Bill Stewart as Vice President. Aye: Fagot, Roberts, Rickertsen, Hagan, Salem, Stewart. Nay: None. Motion carried.

Pepplitsch reviewed a financial report and gave a report on the status of the Lexington East Viaduct project environmental assessment process. Following discussion, no formal action was taken.

Discussion was held on a draft FY 2019 budget. Following discussion a resolution was presented to request tax levy authority. Motion was made by Fagot and seconded by Rickertsen to approve Resolution #2018-01 as presented. Aye: Salem, Roberts, Hagan, Rickertsen, Stewart, and Fagot. Nay: None. Motion carried.

Being no further agenda items, the meeting was adjourned.
