Members of the City Council present were: Mayor John Wightman, Robert Hawks, Dorothy Anderson, Jerry Long and John Fagot. City Officials present were: City Manager Bill Podraza, City Clerk Leon E. Malzahn and City Attorney Will Weinhold. Department Heads present were: Vance Bricker, and Charlie Clark. Also present were: Dana Daniels and Bob Blankenship representing Miller & Associates and Rich Bukovinsky and Ray Meyers representing Regional Insurance Managers, Inc. Citizens in attendance were: Dan and Marilyn Sabin. The press was represented by the Clipper Herald, the Tri-City Tribune and KRVN.

The meeting was called to order by Mayor John Wightman.

## **CLAIMS AND BILLS:**

Claims and Bills in the amount of \$872,023.04 were presented for Council's consideration and approval. After a discussion concerning the bill to Paulsen Development of Lexington, Nebraska for construction of Fillmore Street, moved by Anderson, seconded by Hawks to remove that claim from the list of bills making the total bills listed as \$852,382.81 and authorized the City Treasurer to transfer \$165,611.68 from the General Fund, \$642,359.50 from LEXUS \$10,000.00 from City Sanitation Fund, Funds. \$21,491.64 from the Landfill Fund, \$228.15 from the Library Memorial, \$3,378.37 from the Health Fund, and \$9,313.47 from Meals on Wheels to the Lexington Operating Account. Roll call. Voting "ave" Long, Fagot, Hawks, Anderson, Wightman. Motion carried.

MOBILE HOME An ordinance entitled, "AN ORDINANCE TO

PROVIDE FOR

ORDINANCE: RULE EXCEPTIONS IN GRANTING MOBILE HOME PARK PERMITS AND SPECIAL USE PERMITS; TO REPEAL ANY ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM." was read before the council. Moved by Hawks, seconded by Fagot that said ordinance be passed on third and final reading. Roll call. Voting "aye" were: Anderson, Long, Fagot, Hawks, Wightman. Motion carried. The passage and adoption of said ordinance having been concurred by a majority of the Council, the President declared said ordinance be adopted and signed the same. The Municipal Clerk attested to the passage and adoption of the ordinance by affixing his signature and the Seal of the City of Lexington in declaring Ordinance No. 2022 to be published in pamphlet form.

ABANDONED VEHICLE The Lexington City Council considered an ordinance for the removal and disposal of abandoned and junk vehicles. ORDINANCE: Included in this ordinance was a paragraph which allowed the entrance upon property to remove vehicles and set a fee for their towing. Upon further discussion, city administration has requested that this paragraph be stricken from the ordinance and that administration be allowed to set the towing fee. After a discussion, moved by Fagot, seconded by Long to amend the ordinance presented by removing Section 3 of the ordinance presented. Roll call. Voting "aye" were: Hawks, Anderson, Long, Fagot, Wightman. Motion carried. Ordinance No. 2023 entitled, "AN ORDINANCE TO AMEND SECTIONS 18-2, 18-2.1. AND 16-91 OF THE LEXINGTON CITY CODE: TO DEFINE UNLICENSED MOTOR VEHICLES A NUISANCE, AND TO PROVIDE FOR REMOVAL OF SAID VEHICLES FROM PRIVATE PROPERTY: TO INCREASE TOWING FEES; TO REPEAL ORIGINAL SECTIONS 18-2, 18-2.1, AND 16-91, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM." was read before the council. Moved by Hawks, seconded by Fagot that the rules requiring the reading of said ordinance of three separate days be suspended. Roll call. Voting "aye" were: Anderson, Long, Fagot, Hawks, Wightman. Motion carried. Said ordinance was then read by title. Moved by Hawks, seconded by Long that Ordinance No. 2023 be passed on third and final reading. Roll call. Voting "aye" were: Fagot, Anderson, Long, Hawks, Wightman. The passage and adoption of said

ordinance having been concurred by a majority of the Council, the President declared said ordinance be adopted and signed the same. The Municipal Clerk attested to the passage and adoption of the ordinance by affixing his signature and the Seal of the City of Lexington in declaring Ordinance No. 2023 to be published in pamphlet form.

TAPPING FEE An ordinance entitled, "AN ORDINANCE TO AMEND ORDINANCE: ARTICLE 23 OF THE LEXINGTON CITY CODE; TO MAKE PROVISION FOR STORM SEWER TAPS AND TO PROVIDE FOR PERMITS AND FEES; TO REPEAL ANY ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM." was read before the council. City Manager Podraza stated that the cost in this ordinance should be \$400 for tapping a sewer for heat pump, \$100 when tapping a sewer for a sump pump. Moved by Hawks, seconded by Fagot that this ordinance be passed on third reading. Roll call. Voting "aye" were: Long, Anderson, Fagot, Hawks, Wightman. Motion carried. The passage and adoption of said ordinance having been concurred by a majority of the Council, the President declared said ordinance b e adopted and signed the same.

The Municipal Clerk attested to the passage and adoption of the ordinance by affixing his signature and the Seal of the City of Lexington in declaring Ordinance No. 2024 to be published in pamphlet form.

RECYCLING City Manager Podraza informed the council of the AGREEMENT: coalition of cities that were combining resources to form a coop whereby the coop would deliver papers to the recycler. The recycler would credit the members of the coop for the amount of paper they delivered and when sold, would reimburse that cooperative member. He then reviewed the steps that had been taken concerning recycling of newspapers in Lexington by the Lions Club and the possibility of a paper drive in Lexington with the Lions Club and Boy Scouts performing the duty of collecting the newspapers and charging the city for their services. Upon completion of the discussion, moved by Hawks, seconded by Anderson to authorize the City Manager to enter into a cooperative agreement for recycling newspapers. Roll call. Voting "aye" were: Fagot, Long, Anderson Hawks, Wightman. Motion carried.

U.P.R.R. EASEMENT: City Manager Podraza presented an easement to the Lexington City Council for sewer line encroachments. Mr. Podraza stated that this easement, as opposed to the electric easement has a cost of \$1,000 per year which was negotiated down from \$2,000 per year. Upon completion of this presentation, moved by Hawks, seconded by Long to approve the easement and payment of costs to Union Pacific Railroad for sewer line encroachments. Roll call. Voting "aye" were: Anderson, Fagot, Long, Hawks, Wightman. Motion carried.

PAY ESTIMATE: The Lexington City Council considered a request from BSB Construction in the amount of \$6,061.00. Mr. Dana Daniels addressed the Lexington City Council stating that a change order had been incorporated into this pay estimate and this pay estimate was for the installation of gas monitoring wells at the landfill. Moved by Hawks, seconded by Anderson to approve application No. 3 from BSB Construction for work completed at the landfill in the amount of \$6,061.00. Roll call. Voting "aye" were: Fagot, Long, Anderson, Hawks, Wightman. Motion carried.

CONTRACT Dan and Marilyn Sabin addressed the Lexington City EXTENSION: Council requesting an extension for renewal of their contract for a period of six years to help defray the capital costs of installing a one-man

garbage pickup system. The Sabins explained to the council that with the system, four houses would be placed on one-three hundred gallon garbage container in the place where there are alleys. For the customers who do not have alleys, a 90 gallon container would be placed at their house which the container would be on wheels and it could be rolled to the street on pickup date. In conclusion, they stated that this change in equipment for collection of garbage would be an investment of approximately \$500,000. No further discussion. Moved by Hawks, seconded by Long to approve a six year contract for the Sabins for collection of garbage. Roll call. Voting "aye" were: Anderson, Fagot, Long, Hawks, Wightman. Motion carried

HAVEN HOUSE City Manager Podraza presented a contract with DED CONTRACT: for a grant to Haven House. The City Manager stated that the city is required to receive the funds and pass them through to Haven House retaining a portion for administrative costs. Moved by Anderson, seconded by Long to authorize the mayor to enter into an agreement with the Department of Economic Development for a grant for Haven House. Roll call. Voting "aye" were: Hawks, Fagot, Long, Anderson, Wightman. Motion carried.

WEST CENTRAL AREA City Manager Podraza presented a contract to the AGENCY ON AGING Lexington City Council regarding the meals served CONTRACT: at the Grand Generation Center. Mr. Podraza reviewed the declining rate per meal and the attendance at the center stating that the attendance has increased over the past years. Upon completion of the presentation, moved by Fagot, seconded by Anderson to authorize the City Manager to sign a contract with West Central Area Agency on Aging for meal subsidies at the Grand Generation Center. Roll call. Voting "aye" were: Hawks, Long, Anderson, Fagot, Wightman. Motion carried.

FINAL ACCEPTANCE The Lexington City Council considered application FILLMORE STREET: No. 5 which is final payment for construction on Fillmore Street from Paulsen Development in the amount of \$19,640.23. During the discussion, an area of the street where water stands which could be described as an area approximately two foot wide and six foot long was debated whether payment should be paid in full or whether that area should be re-excavated to match the other. Mr. Daniels, representing Miller & Associates stated it would take more than just that area of the street to be re-excavated in order to stop the ponding of water. An additional withholding was discussed as reported

to the council that Paulsen Development has refunded \$8,000.00 to the city as requested when the specs were changed. Upon completion of the discussion, moved by Long, seconded by Wightman to approve Application No. 5 which is a final pay estimate for the Fillmore Street Project to Paulsen Development Construction, Inc. of Lexington, Nebraska in the amount of \$19,640.23 and accept the engineers certificate of substantial completion. Roll call. Voting "aye" were: Anderson, Wightman, Long. Voting "nay" were: Hawks, Fagot. Motion carried.

**HEALTH INSURANCE:** Mr. Rich Bukovinsky, representing Regional Insurance Managers, Inc. addressed the Lexington City Council with an explanation of the PPO system and the HMO system of health care that is currently on the reform throughout the United States. Mr. Bukovinsky explained the possibilities and the savings that the City of Lexington and its employees would receive if they were to join the PPO which is Midlands Choice and is supported by Tri-County Hospital in Lexington. Additionally, he explained the existence of other PPO's in Kearney, Cozad and Callaway. Upon completion of his presentation, the City Council requested the hospital administrator attend the next regular council meeting explaining the reason and advantages of joining Midlands Choice which is the PPO organization Tri-County Hospital has joined. Additionally, Mr. Bukovinsky reviewed the benefits of our current health insurance program and a change that would affect those people having required surgery to pay 80/20 of the first \$2,000 as opposed to 50/50. Upon completion of his presentation, no action was taken.

TREASURERS REPORT: Deputy City Treasurer Leon E. Malzahn presented the Treasurers report for April, 1995 highlighting some of the major expenses and incomes. Upon completion of the report, moved by Long, seconded by Anderson to accept the Treasurers Report for April, 1995. Roll call. Voting "aye" were: Hawks, Fagot, Anderson, Long, Wightman. Motion carried.

ROOF BIDS: City Manager Podraza stated that he had advertised for bids for repair of the firebarn roof. One bid had been received from Walker Roofing Company in the amount of \$14,641. He further stated that to further increase the thickness to 60 mils rather than 45 mils would be an additional \$690. He would recommend that this be placed in the contract. After further consideration, moved by Hawks, seconded Long to award the bid to Walker Roofing

for the 60 mils membrane in the amount of \$14,641 plus \$690 for the additional thickness. Roll call. Voting "aye" were: Fagot, Anderson, Long, Hawks, Wightman. Motion carried.

ADJOURNMENT: There being no further business to come before the Council, Mayor Wightman declared the meeting adjourned.
