#### **TRUCK BIDS:**

City Manager Vance Bricker, and Community Services Director Glenn Hawks addressed the City Council requesting Administration's authority to advertise for bids for a dump truck for the Street Department. Moved by Fagot, seconded by Mandelko to authorize the City Administration to advertise for a dump truck for the Street Department. Roll call. Voting "aye" were Kohl, Klamm, Mandelko, Fagot, Wightman. Motion carried.

WCAA CONTRACT: The West Central Agency on Aging contract for Meals on Wheels was presented for the Council's review. Ms. Ann Luther, Director of the Grand Generation Center addressed the City Council, and reviewed the statistics for the previous year, and the part this contract plays in paying for part of the meals. Upon completion and review of the report. Moved by Klamm, seconded by Fagot to authorize the Mayor to sign the contract with the West Central Agency on Aging for subsidy of Meals program. Roll call. Voting "aye" were Mandelko, Kohl, Fagot, Klamm, Wightman. Motion carried.

BOURKE/ The Lexington City Council held a public hearing to receive

#### NITSCH SUBDIVISION:

input on the proposed subdivision presented by Bourke and Nitsch on the north edge of their current property. Mr. Jeff Bourke was present and addressed the City Council stating that this property would be located north of their property. between them and the John Deere dealership. Also present was Debby Schmitt, representing a company that is planning to locate there, stating that the company sells feed delivery equipment. They have a store in Dodge City, Kansas, as well as their main office in, Brush, Colorado. completion of the presentation, there were no comments in opposition to the subdivision, Mayor Wightman declared the public hearing closed. An ordinance entitled "An Ordinance to rezone a tract of land in Bourke/Nitsch Subdivision from A-1 Agricultural District to M-2 Heavy Industrial District", was read before the Council. Moved by Fagot, seconded by Klamm, that the rules requiring the reading of said ordinances on three separate days be suspended. Roll Voting "aye" were Kohl, Mandelko, Klamm, Fagot, Wightman. Motion carried. Said ordinances was then read Moved by Klamm, seconded by Fagot that by title. Ordinance 2080 be passed on final reading. Roll call. Those voting "aye" were Mandelko, Kohl, Fagot, Klamm, Wightman. Motion carried. The passage and adoption of said ordinance having been concurred by a majority of the Council, the President declared said ordinance be adopted and signed the same. The Municipal Clerk attested to the passage and adoption of the ordinance by affixing his signature and the Seal of the City of Lexington in declaring Ordinance No. 2080 to be published in pamphlet form.

### LIQUOR LICENSE EL TROPICO:

The Lexington City Council held a public hearing to consider the request of Juan Rene Lazo for a bottle club and beer offsale only license at the El Tropico, 201 E. 5<sup>th</sup> Street, Lexington, Nebraska. Mr. Scott Truesdale, on behalf of Juan Lazo, addressed the Lexington City Council, stating that Mr. Lazo is making application for this liquor license so this may be served during the activities scheduled at his place of business. Mr. Lazo stated that current activities at this business would include dancing however he wishes to add a pool table, and then a kitchen at a later date. Mr. Truesdale stated that he felt Mr. Lazo was operating his business to fulfill requests by a segment of our population. The City Council then inquired the Chief of Police if there had been any complaints concerning previous activities at this establishment. Mr. Clark advised the Council that the only complaints that he had received was about littering. The Council directed questions at Mr. Lazo concerning his previous activities in this building. Mr. Lazo stated his previous activities where alcohol was consumed was allowed because the parties were private parties by invitation only, or special designated permits for serving liquor. Hearing no further comments concerning this license, Mayor Wightman declared the public hearing closed. It was moved by Kohl, seconded by Klamm to recommend approval of this liquor license to Juan Lazo at 201 East 5<sup>th</sup> Street for a Class M Bottle Club and Class B, Beer Off-Sale Voting "aye" were Klamm, Kohl, License. Roll call. Wightman. Voting "nay" was Fagot and Mandelko. Motion carried.

AQUATIC CENTER: Mr. Chris Huff addressed the Lexington City Council reporting on the first week's activities on the Aquatic Center. which included number of occupants, the types of passes that were sold, and activity at the concession stand. Mr. Huff also reported on other recreation programs and other activities planned for the future. Upon completion of the report, no further action was taken.

#### POLICY APPROVAL:

City Manager Bricker presented a policy for competitive proposals for services. Mr. Bricker stated that this policy would be in force for procuring services such as engineering, accounting, and legal fees. It is required by a community development block grant program in order to quality for grants. Upon completion of the review, moved by Klamm, seconded by Mandelko to approve the procurement of this policy as presented by the City Manager. Roll call. Voting "aye" were Fagot, Kohl, Mandelko, Klamm, Wightman. Motion carried.

#### **FINANCIAL** REPORT:

Ms. Kerry Rader addressed the Lexington City Council reviewing the Financial Report for the City of Lexington for March, 1997. Upon the completion of her review, moved by Mandelko, seconded by Kohl, to accept the Financial Report for March, 1997. Roll call. Voting "aye" were Fagot, Klamm, Kohl, Mandelko, Wightman. Motion carried.

### **PAY ESTIMATE** NO 8-M:

The Lexington City Council reviewed pay estimate No. 8-M from Associated Pool Builders for pool mechanical contract at the Aquatic Center. Upon completion of this review and the discussion of retainage. Moved by Klamm, seconded by Fagot, to approve application No. 8-M from Associated Pool Builders, Inc. of Bismark, N.D. in the amount of \$26,900.00 and authorize the City Treasurer to transfer \$26,900.00 from the Aquatic Funds to the City of Lexington Operating Account. Roll call. Voting "aye" were Mandelko, Kohl, Fagot, Klamm, Wightman. Motion carried.

# PAY ESTIMATE NO. 10-C:

The Lexington City Council reviewed Pay Estimate No. 10-C from Associated Pool Builders, Inc., Bismark, North Dakota, for pool construction. Upon review of this contract. Moved by Kohl, seconded by Mandelko, that Pay Estimate No. 10-C in the amount of \$57,200.00 from Associated Pool Builders, Inc. of Bismark, N.D. be approved, and authorize the City Treasurer to transfer \$57,200.00 from Aquatic Funds to the City of Lexington Operating Account. Roll call. Voting "aye" were Klamm, Fagot, Mandelko, Kohl, Wightman. Motion carried.

# PAY ESTIMATE NO. 11:

Pay Estimate No. 11 from Paulson Incorporated for the general construction of the Aquatic Center was presented for Council's consideration and approval. Upon review of Pay Estimate No. 11. Moved by Fagot, seconded by Mandelko, that pay estimate from Paulson Inc., of Cozad, NE for general construction of the Aquatic Center, in the amount of \$71,293.00 be approved, and the City Treasurer be authorized to transfer \$71,293.00 from the Aquatic Funds to the City of Lexington Operating Account. Roll call. Voting "aye" were Klamm, Kohl, Mandelko, Fagot, Wightman. Motion carried.

#### ADJOURNMENT:

There being no further business to come before the Council, Mayor Wightman declared the meeting adjourned.
