A Special Meeting of the Lexington City Council was held Tuesday, March 17, 1998 at the Lexington Municipal Offices, 406 East 7<sup>th</sup> Street, Lexington, Nebraska at 7:30 a.m. Members of the Council present were Mayor John Wightman, John Fagot Neal Kohl, Rick Klamm and Patty Mandelko. City Officials present were City Clerk Leon Malzahn, City Manager Vance Bricker. Department Heads present were Assistant City Manager Joe Pepplitsch.

**NOTICE:**

Notice of the meeting was posted in the City Municipal Building, United Nebraska Bank, Farmers State Bank, and the Dawson County Courthouse. Notice of this meeting was simultaneously given to the Mayor and all members of the council, and a copy of their Acknowledgment of Receipt of Notice and the Agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this meeting. The proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. all items presented and discussed on the Agenda were available for public inspection.

**CALL TO ORDER:**

The meeting was called to order by Mayor Wightman.

**WATER WELL BIDS:**

City Manager Bricker addressed the Lexington City Council requesting the rejection of the water well bid from Liehs Drilling in the amount of \$165,000.00, and authorize the City Administration to negotiate. Mr. Bricker further explained that in the negotiations, the design of the well would be changed so that it would reduce the cost of the well. He further stated that this well would still be approximately \$20,000.00 over the budgeted item. Upon completion of his presentation, moved by Kohl, seconded by Mandelko to reject the bid from Liehs Drilling for Municipal Well No. 16 in the amount of \$165,000.00, and authorize the City Administration to negotiate for the construction of this well. Roll call. Voting "aye" were Fagot, Klamm, Mandelko, Kohl, Wightman. Motion carried.

**ADJOURNMENT:**

There being no further business to come before the Council, Mayor Wightman declared the meeting adjourned.
