## CERTIFICATE OF FINAL COMPLETION:

Bob Blankenship, representing Miller and Associates,

presented a Certificate of Final Completion on Grant and 20<sup>th</sup> Street Water Line Project. The Certificate shows the adjusted quantities on the project, as they reflect what was completed and installed by Midlands Contracting. Moved by Wightman, seconded by Kohl, to accept the Certificate of Final Completion on the Grant and 20<sup>th</sup> Street Water Line Project. Roll call. Voting "aye" were Klamm, Cook, Kohl, Wightman, Fagot. Motion carried.

## FINAL PAY ESTIMATE:

Mr. Bob Blankenship, representing Miller and Associates presented the Final Pay Estimate Number 3. Mr. Blankenship stated that the only difference between this Estimate, and the one approved earlier, is the sod on Grant Street. All the other items remain the same. Moved by Wightman, seconded by Kohl, to approve the Final Pay Estimate on the Grant and 20<sup>th</sup> Street Water Line. Roll call. Voting "aye" were Cook, Klamm, Kohl, Wightman, Fagot. Motion carried.

## **LIQUOR LICENSE:**

Upon Mayor Fagot opening the Public Hearing, Wes Lubberstedt, representing Mr. Adolfo Flores, who is the major stockholder in LaMexicana Inc., addressed the Lexington City Council, requesting a Liquor License for Mr. Flores. Mr. Lubberstedt gave a brief history of Mr. Flores, his business, and his family. The request is for a license to apply to substantially all of the building except the southeast corner, and there is no access from the southeast corner of the building into his part of the building. The request if for a Bottle-Club License, which would allow him to serve on-sale spirits.

Mr. Adolfo Florez addressed the Lexington City Council stating that he has applied for this Liquor License because of the customer demand for the beverages. His aim is to please his customers. Following the presentations, Mayor Fagot closed the Public Hearing. Moved by Wightman, seconded by Klamm, to recommend approval of the Class M Liquor License for LaMexicana Inc. Roll call. Voting "aye" were Kohl, Cook, Klamm, Wightman, Fagot. Motion carried.

SUNDAY LIQUOR SALES:

Mr. Tom Mooberry, representing Tom's Midwest

Liquor, speaking on behalf of John's Liquor, Mac's Short Shop, Len's Liquor, Sav-A-Lot Grocery Store, the thousands of customers that come to their stores every week, and himself, addressed the Lexington City Council requesting them to consider approval of the sale of off-sale liquor on Sundays in the City of Lexington, which already allows the sale of off-sale beer and wine on Sundays. Due to the many requests from customers, they feel the addition of hard liquor would be another plus for Lexington, its residents, and the economy.

Barry Carpenter, representing Sav-A-Lot, stated that Sundays are the only day off for a lot of people in town, and that when they like to do their shopping. Council Person Wightman informed Mr. Mooberry that in order to do this, they would have to do it by Ordinance. Mayor Fagot requested City Attorney Weinhold to draw up an Ordinance so the Lexington City Council can have it put on the Agenda at the next Council Meeting.

**MISCELLANEOUS:** 

City Manager Bricker addressed the Lexington City Council stating that the Lexington Area Solid Waste Agency Executive Board interviewed applicants for the Manager last week. There were approximately 15 applicants for the position, and five people were interviewed. The job was offered to a person from Wray, Colorado, and hopefully he will begin as Manager of the Agency on December 1, 1999.

City Manager Bricker informed the Lexington City Council that October 13 - 15, the Nebraska League of Municipalities will be having their 1999 Annual Conference. Assistant City Manager Joe Pepplitsch, Mayor John Fagot, and himself will be attending. City Manager Bricker will be speaking on the 15<sup>th</sup> at 8:30 a.m. on Council Managers and Relations.

Council Person Ted Cook inquired about the trash containers being permanently left out on the west side of Jefferson Street between 14<sup>th</sup> and 16<sup>th</sup> Streets. City Manager Vance Bricker informed the City Council that the problem had been discussed, and Chief Building Inspector Tom Nelson has been working on it. He has left notices at each house on the street, and also moved the Trash Containers back into the yards. City Manager Bricker has instructed Mr. Nelson to keep issuing the citations until the residents start cooperating.

**ADJOURNMENT:** 

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
