TOTAL CLAIMS

TREE BOARD REPORT:

Barb Gydesen, and Alvin Zimmerman addressed the Lexington City Council explaining to them the projects that have been completed by the Tree Board. Namely the beautification of the Triangle by the Water Tower, and other projects such as planting trees in town. They also informed the Council of the next plan project, which would be the beautification of a triangle on Highway 30, between Jackson and Grant Street. Additionally, they informed the Council that a grant had been received whereby any diseased trees on public and private property, could be removed with the owner paying only \$25.00 to have this completed. Additionally, they would qualify for a replacement tree, which would be funded by this grant. Upon completion of this report, no further action was taken.

TREE BOARD MEMBERS:

Barb Gydesen, and Alvin Zimmerman continued by requesting the City Council increase the Tree Board from five to seven members and allow the outside area around Lexington to be included in their jurisdiction. They also informed the Council that there was a possibility, they were thinking about including Johnson Lake for their Members of the Board. After discussion, Mayor Fagot stated that he was not in favor of increasing members of the Tree Board to seven just to have that many members. Five seems to be adequate to accommodate the current activities. Mr. Zimmerman further stated that they would like to have the Board increase so they could also include two members of City Staff, namely Glenn Hawks and Doug Monter, as members, at which time, there was a question raised to that option by the Council. Upon conclusion of discussion, an Ordinance entitled "AN ORDINANCE TO

AMEND SECTIONS 2-35 AND 2-36 OF THE LEXINGTON CITY CODE; TO PROVIDE FOR ADDITIONAL MEMBERS ON THE CITY TREE BOARD; TO REPEAL ORIGINAL SECTIONS 2-35 AND 2-36, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before the Council. Moved by Klamm, seconded by Kohl, that said ordinance be passed on first reading. Roll call. Voting "aye" were Kohl, Klamm, Fagot. Voting "nay" was Cook. Motion carried.

GRAFFITI ORDINANCE:

An Ordinance entitled "AN ORDINANCE TO AMEND SECTION 18-1 OF THE LEXINGTON CITY CODE; TO PROVIDE FOR REMOVAL OF GRAFFITI AS A NUISANCE; TO REPEAL ORIGINAL SECTION 18-1, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before the Council. After a discussion concerning this ordinance, moved by Kohl, seconded by Klamm, that said Ordinance be passed on second reading. Roll call. Voting "aye" were Cook, Kohl, Klamm, Fagot. Motion carried.

SUNDAY ALCOHOL:

An Ordinance entitled "AN ORDINANCE TO AMEND SECTION 3-6 OF THE LEXINGTON CITY CODE; TO PROVIDE FOR SUNDAY SALES OF ALCOHOLIC LIQUOR FOR CONSUMPTION OFF THE PREMISES; TO REPEAL ORIGINAL SECTION 6-3, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM' was read before the Council. Hearing from Tom Mooberry, representing most of the off-sale establishments in town, asked the Council pass this Ordinance on third reading, as presented. Mr. Fernando Barrenco addressed the City Council stated he sees cases in his occupation, "Heartland Counseling" where drinking is a problem, and is afraid this would increase with the passage of this Ordinance. Council Person Klamm stated that doing some calculation on the amount of sales as reported two meetings ago, he sees only that this would possibly increase liquor sales by 1/28, therefore he would move that Ordinance No. 2114 be passed on final reading, seconded by Kohl. Roll call. Voting "aye" were Cook, Kohl, Klamm, Fagot. Motion carried.

The passage and adoption of said Ordinance having been concurred with by a majority of all members elected to the Council, was by the Mayor declared passed and adopted, and the Mayor, in the presence of the Council, signed and approved said Ordinance, and the Clerk attested the passage and approval of the same and affixed the seal of the City thereto.

Moved by Klamm, seconded by Kohl, to recess the Regular Session into Executive Session at 7:53 p.m. Roll call. Voting "aye" were Cook, Kohl, Klamm, Fagot. Motion carried.

Moved by Klamm, seconded by Cook, to reconvene the Regular Session from Executive Session at 8:29 p.m. Roll call. Voting "aye" were Kohl, Cook, Klamm, Fagot. Motion carried.

COMMENTS:

City Manager Bricker informed the Council that there would be a joint meeting tentatively for January 8, 2000 between Lexington, Cozad, Gothenburg, and Dawson County to discuss the possibility of a bond issue, to fund an additional cell at the Solid Waste Facility north of town.

Council Person Kohl requested Memorial Park be closed at 6:00 p.m., as there have been activities in the park that should not be carried on at that location. He also requested that the City look at a Billboard Ordinance such as Lincoln, Nebraska has restricting the placement of Billboards. He said this question was raised concerning

Billboards on West Highway 30.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
