LIQUOR LICENSE:

The Lexington City Council held a public hearing to consider the application of the Dragon Garden for a wine and beer on-sale only liquor license. Mr. Dave Smith, representing the Woo Family,

addressed the Lexington City Council, introduced the members of the family to the City Council, requesting that they could have a license like this to sell their beer and wine with their meals. Upon the conclusion of his presentation, and no further comments to be received, Mayor Fagot declared the public hearing closed. Moved by Wightman, seconded by Klamm, that the City Council forward a recommendation of approval to the Nebraska Liquor Control Commission with regard to the application of the Dragon Garden Inc. for a Class J Retail Liquor License. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

PUBLIC HEARING:

The Lexington City Council held a public hearing to consider the application of El Farol for a Class M Bottle Club Restaurant at 501 Plum Creek Parkway. Mr. Feliciano Vasquex addressed the Lexington City Council stating that he is requesting a Bottle Club License so that he may serve alcohol with the meals if requested by his patrons. After a review of the application, Mayor Fagot declared the public hearing closed. Moved by Kohl, seconded by Klamm that the City Council forward a recommendation of approval to the Nebraska Liquor Control Commission with regard to the application of El Farol Restaurant for a Class M Retail Liquor License. Roll call. Voting "aye" were Wightman, Cook, Klamm, Kohl, Fagot. Motion carried.

BLUE BEACH LIQUOR LICENSE:

The Lexington City Council held a public hearing to consider the application of Bueno Gonzalez for a Bottle Club Liquor License for the Blue Bleach at 501 Plum Creek Parkway, Suite B. Upon review of his application, Council person Wightman questioned the lack of information on the license and how the Liquor Control Commission could have forwarded this, in this manner. Also, Council Person Wightman asked Mr. Gonzalez whether he had previous experience operating a restaurant, and the number of years that he had been in Lexington, and also requested where he had lived prior to becoming a resident in Lexington. Prior to living in Lexington, Mr. Gonzalez he had been in California. Additional questions were, if a wall between the Blue Beach and the El Farol Restaurant were constructed, if this were a separate business, he answered to the affirmative on that. Also related was the fact that there was a door between the two which would remain locked. Hearing no further comments, Mayor Fagot declared the public hearing closed. Moved by Kohl, seconded by Klamm, that the City Council forward a recommendation of approval to the Nebraska Liquor Control Commission with regard to the application from Blue Beach for a Bottle Club Retail Liquor License. Roll call. Voting "aye" were Wightman, Cook, Klamm, Kohl, Fagot. Motion carried.

UPRR AGREEMENT:

City Manager Bricker addressed the Lexington City Council stating that we needed to have this agreement signed with Union Pacific Rail Road in order to proceed with the replacement with the water main casing under the Madison Street crossing. Upon completion of his presentation, moved by Wightman, seconded by Kohl, that the following resolution be passed and approved. Roll call. Voting "aye" were Cook, Klamm, Kohl, Wightman, Fagot. Motion carried.

RESOLUTION 99-01

13th STREET ORDINANCE:

The Lexington City Council considered an Ordinance

that would increase the speed on 13th Street from 25 to 30 m.p.h. and reduced parking in certain areas along that street. Testifying in opposition to this ordinance were Greg Stucklik, Ivan Henderson, Hap Hardesty, and approximately two other citizens, all stating that the control of the speed is not there, and people drive upwards to 50 m.p.h. on that street. After hearing all the objections from the citizens for not passing this ordinance, moved by Klamm that said Ordinance be passed on first reading. Hearing no second in motion, Mayor Fagot declared the motion dead for lack of second. Moved by Wightman, seconded by Klamm, that the Ordinance be placed on the next regular council meeting agenda for February 9, 1999. Roll call. Voting "aye" were

Klamm, Wightman. Voting "nay" were Cook, Kohl, Fagot. Motion failed.

BLIGHTED AREA STUDY:

City Manager Bricker informed the Council that a time and place for a blighted hearing study needed to be set and the following resolution would do that. This would be to pave the way for the Community Redevelopment Authority to act upon the Holiday Inn Express which is planned to be built along Plum Creek Parkway. After the completion of his presentation, moved by Wightman, seconded by Kohl, that the following resolution be passed and approved. Roll call. Voting "aye" were Klamm, Cook, Kohl, Wightman, Fagot. Motion carried.

RESOLUTION 99-02

A hearing on the question of whether the area described in the report should be declared blighted and substandard shall be held in the City Council chambers on February 23, 1999, at the hour of 7:30 P.M..

the City Clerk is directed to publish notice of the hearing once each week for two weeks prior to said hearing.

The City Clerk is further directed to mail notice after the first publication thereof by certified mail to the president or chairperson of the governing body of the county, school district, community college, educational service unit and natural resource district.
