STATUS REPORT:

At this time, Mr. Dana Daniels presented a computer generated video program of the proposed routes of access to Highway 30 via the overpass on Adams Street. Six different options were presented to the Council, with routing the traffic on the north side of Adams Street through various residential areas, and non-residential areas, back to Highway 30. Upon completion of the report, moved by Wightman, seconded by Klamm, to accept the Status Report on the Overpass progress. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

PROGRESS PAYMENT:

The Lexington City Council considered payment request No. 1, and final, from Midland Contracting for the work completed on the Madison Street Water Main Water Main under crossing. City Manager Bricker informed the Council that this project is complete, and was done by an RFP, as it was an emergency situation with the water main break under the rail road tracks at the Madison Street crossing. Upon completion of his report, and a verification from Mr. Dana Daniels, representing Miller and Associates, about the work being completed as stated on the pay estimate. Moved by Klamm, seconded by Kohl, that Application No. 1, and final, to Midland Contracting Inc. in the amount of \$44,400 be approved and authorize the City Treasurer to transfer \$44,400 from the water funds to the City of Lexington Operating Account. Roll call. Voting "aye" were Wightman, Cook, Kohl, Klamm, Fagot. Motion carried.

CERTIFICATE OF SUBSTANTIAL COMPLETION:

The Lexington City Council reviewed the Certificate of Substantial Completion for the Madison Street

Water Main Under Crossing Project is complete and is useful by the City of Lexington. Upon the completion of his report, moved by Wightman, seconded by Klamm, to approve the Engineer's Certificate

of Substantial Completion in the amount of \$44,400. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

PUBLIC HEARING:

The Lexington City Council held a public hearing to consider a request from Randy Chapman to rezone the property located at 911 North Adams Street from R-4 (multi-family housing) to C-3 (Highway commercial). Mr. Bruce Bonini addressed the Lexington City Council stating that he is the one who is really requesting the rezoning, although, Randy Chapman, does own that lot. His reason for the rezoning would be so he could sell cars off of that part of the lot, with the proper zoning. With the R-4 (multi-family housing), he would not be able to sell cars at that location. He further stated that Mr. Chapman is planning on building a building back there, but it would be within compliance. Upon completion of his presentation, and no further comments, Mayor Fagot declared the public hearing closed.

ZONING ORDINANCE:

An Ordinance entitled "AN ORDINANCE TO REZONE THE WEST 100 FEET OF THE EAST 200 FEET OF THE NORTH 140 FEET, OF BLOCK 1, MACCOLLS ADDITION TO THE CITY OF LEXINGTON, FROM R-4 MOBILE HOME DWELLING DISTRICT TO C-3 HIGHWAY COMMERCIAL DISTRICT; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before the Council. Hearing no objections to the previous public hearing, moved by Wightman, seconded by Klamm, that said ordinance be passed on first reading. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

FIRE DEPT. ROSTER:

The Lexington City Council reviewed the roster of the Lexington Volunteer Fire Department containing approximately 36 names. Upon review of the roster, an explanation from the City Attorney, that the City Council, from time to time, should accept the roster of the Volunteer Fire Department, in case there is an injury claim, resulting from an injury, while they are fighting a fire. He further stated that the acceptance of this roster would give proof of membership so the insurance will cover them. Upon completion of the report from the City Attorney, moved by Wightman, seconded by Klamm, to accept the roster of the Lexington Volunteer Fire Department as presented. Roll call. Voting "aye" were Kohl, Cook, Wightman, Klamm, Fagot. Motion carried.

FIRE DEPT. REQUEST:

Mr. Roger Reutlinger, representing the Lexington Volunteer Fire Department, addressed the Lexington City Council, stating that they would like to have a pumper truck replaced in the department. Mr. Reutlinger stated that the new truck would be able to carry approximately 750 gallons of water vs. 500 gallons of water, and would allow the fireman an extended cab to sit inside as they travel to the fire. He further stated that this would replace a 1972 Dodge Pumper in the current list of equipment, which is now approximately the third truck down. Mr. Reutlinger further stated that the estimated cost of this new truck is between \$225,000 and \$250,000, and the salvage value of the 1972 Dodge, is approximately \$7,000 - \$10,000. Upon the completion of his request, Mr. Reutlinger was asked about the number of miles on this truck, to which he replied, there was approximately 16,000. He

was further asked if the lining of the tank, which supposedly was corroding, could be relined to repair the corroding. He further stated that this is possible, however, the piping and everything to the pump, and the hours on the motor, probably would not pay for the cost of refurbishing those items and equipment. After a discussion of the financing that was available to purchase this truck, the City Council informed Mr. Reutlinger that they would feel more comfortable if this truck was run through the budget process, versus, buying it without it being in the current budget. No further action was taken.

POLICE DEPT. REPORT:

Chief Charles Clark, of the Lexington Police Department, presented a report of the 1998 activities of the Lexington Police Department, pointing out various increases, or decreases, in certain areas with an explanation. Upon completion of his report, no further action was taken.

LB 840 REVIEW:

City Manager Bricker informed the council that Mayor Fagot had asked that this item be placed on the Agenda to discuss the possibility of funding economic development through property tax requirements. Various items were discussed, and a discussion of a draft plan was held. Upon completion of the discussion, Mayor Fagot announced that he would like Mr. Rick Klamm, and himself, sit on a committee to develop a plan for Economic Development of Lexington. Further discussion resulted in additional members of this committee being appointed, such as The City manager, members from the CED, Greater Lexington, and Dawson Area Development. Upon completion of the overall discussion of this item, moved by Klamm, and seconded by Wightman, that the City of Lexington further study lb840 and an economic development plan for the city of Lexington to include representation from all committies within the County that are approperate to that. Roll call. Voting "aye" were Cook, Kohl, Wightman, Klamm, Fagot. Motion carried.

AUDIT COMMITTEE REPORT:

A report on the Fiscal Year 1997-98 Audit for the City of Lexington, financial operations was presented to the City Council, for their review. Upon completion of their review, moved by Klamm, seconded by Wightman, to accept the audit report as presented. Roll call. Voting "aye" were Kohl, Cook, Wightman, Klamm, Fagot. Motion carried.

STREET RECLASSIFICATION:

Assistant City Manager Joe Pepplitsch addressed the Lexington City Council stating that the change in traffic patterns caused by the closing of Washington Street crossing need to be reclassified, so the State of Nebraska may update their records on the routing of traffic through Lexington. Upon completion of the report, moved by Wightman, seconded by Klamm, to accept the reclassification of streets in Lexington in accordance with the proposed plat. presented by Assistant City Manager Joe Pepplitsch, and filed with the State of Nebraska Department of Roads. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Wightman declared the meeting adjourned.
