TREE BOARD REPORT:

They also stated that Lexington had qualified for the Tree City USA award and was also looking forward to that same award this year. Activities for this year include the Arbor Day celebration which has various activities within it, as outlined by Mr. Zimmerman. They also outlined the planned activity of placing flowers in the Triangle Parks along Highway 30 and improving the park around the water tower.

NCIP REPORT:

Mr. John Whittington representing the NCIP, addressed the Lexington City Council, stating that the NCIP Board is represented by Tami Reynolds, Liz Richardson, and Gayle Wightman. Mr. Whittington then outlined the activities of the NCIP Board and requested that the City Council pass the resolution allowing Lexington to enter the NCIP for

1999. Upon completion of his report, moved by Wightman, seconded by Klamm, that the following resolution be passed and approved. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

1999 NCIP Government Resolution Resolution #99-07

WHEREAS, local municipal and county government must provide leadership for improving community and economic development efforts; and

WHEREAS, community and economic development needs can best be determined and solved through a cooperative effort between elected officials and the citizens they represent; and

WHEREAS, the Nebraska Community Improvement Program, administered by the Nebraska Department of Economic Development, has been reviewed and found to be a means to improve our community; and

RECREATION REPORT:

Mr. Chris Huff addressed the Lexington City Council reviewing the operation of the Aquatic Center, and a change in the fee schedule recommended by the Recreation Board. Mr. Huff stated that most of the fees had been rounded up to the nearest quarter, alleviating the need for making change at the 13 cent level. He then reviewed the rates that would be in effect, which would, with Council's approval be in effect. For a single admission, Children would be \$2.25, Adults 16 - 54 would be \$3.25, Senior Citizens would be \$2.25, and Family Passes would be \$11.00. Season Tickets for Individual would be \$50.00, and Family Pass would be \$140.00. After reviewing the amount of money it takes per hour to operate the Aquatic Center with concessions, Mr. Huff concluded his report. Speaking in opposition to the increase in fees were Jeannie Holman, Maria Knaggs, Ella Mae Scully, Nancy Price, Terry Casper, and Linda Graus. Most of their comments were that the Family Pass of \$140.00 was too much and needed to be reduced to allow families to afford this fee. After a debate concerning the budget for the Aquatic Center and the operation of the Aquatic Center, moved by Cook to reduce the cost from \$2.25 to \$2.00, \$3.25 to \$3.00, and leave the Family Passes at \$100.00. After a period of time, and hearing no second to the motion, Mayor Fagot declared the motion dead for the lack of a second. After further discussion of rates for the Aquatic Center, moved by Klamm, seconded by Wightman, to refer this situation back to the Recreation Board for their further consideration. Roll call. Voting "aye" were Kohl, Wightman, Klamm, Fagot. Voting "nay" was Cook. Motion carried.

REQUEST FOR BIDS:

Mr. Dana Daniels, representing Miller and Associates, addressed the Lexington City Council with specifications for water main projects on Grant Street, and on 20th Street. He outlined the need for replacement of this main, and moving of the main behind the curb, which would reduce maintenance costs in the future, due to the fact that no pavement would need to be removed and replaced. Upon completion of his presentation, moved by Wightman, seconded by Klamm, to approve the plans and specifications for the replacement of water main on Grant Street and 20th Street, and authorize Administration to advertise for bids. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

SALE OF PROPERTY:

City Manager Bricker stated that Charlie Cadwell had requested to purchase these lots and the Ordinance had been passed and remonstrance period had gone by with no objections, and therefore, the conveyance of the deed by this resolution needed to be accomplished. Upon completion of his report, moved by Klamm, seconded by Wightman, that the following resolution be passed and approved. Roll call. Voting "aye" were Cook, Kohl, Wightman, Klamm, Wightman. Motion carried.

RESOLUTION NO. 99-08

WHEREAS, the City has by Ordinance No. 2108 approved the sale of the following described real estate owned by the City, to-wit:

FOOD HANDLERS:

Mayor Fagot stated that he had some requests on additional regulations for Food Handlers, and maybe some occupation tax, and policing people who are selling food out of mobile homes around town. After the Mayor's statements on Food Handlers, City Manager Bricker stated that they will discuss this problem internally and set up some regulations for additional inspection of these Food Handlers. No further action was taken.

WATER RATES:

Assistant City Manager Pepplitsch addressed the Lexington City Council with a recommended water rate change. He further stated that he based this water rate on the needs of the water department that he related to the Council during the retreat, and additionally stated that contingencies and reconstruction of existing mains throughout the coming years would require that type of revenue to accomplish a program. After a lengthy discussion, by the Council on the affect these new rates would have upon water bills in the City, it was recommended that an additional look be taken at the request for funds and the request be lowered to compensate for the reduction in the proposed rates. No further action was taken.

LANDFILL REPORT:

City Manager Bricker addressed the City Council relating the past history of the Lexington Area Solid Waste Disposal Facility and the reason for the size of the physical structure the site. His presentation also included a forecast of the remaining capacity of the current cell if the inflow of waste continued at the current rate. Mr. Bricker then reviewed the financial structure and Impact the closing of the recycling center would have upon the operation of this facility. Mr. Bricker concluded his report on the ability of the solid waste agency to meet their bond payments and alternative actions that need to occur if this situation were to come to pass.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Wightman declared the meeting adjourned.
