### GRAND TOTAL:

### **CITIZEN'S COMMENTS:**

Mr. Frank Hennigan addressed the Lexington City Council regarding the beer garden at the Old Fashioned 4<sup>th</sup> of July. Mr. Hennigan stated that every town around Lexington is a growing community, and that Lexington is completely stagnant. He believes Lexington needs to do something constructive to draw and keep people here. He further stated that the people of Lexington go else-where for entertainment because nothing is offered here. Chamber of Commerce Director John Whittington addressed the Lexington City Council stating that the Chamber would like to go ahead with the plans with a beer garden, but didn't want to offend anyone. Following Mr. Whittington's comments, Mr. Hennigan requested this topic be brought before the Council at the next meeting.

Ruth Magoon, representing the Evangelical Free Church, and other concerned citizens, addressed the Lexington City Council regarding the Adult Book Store that recently opened. She is concerned with what will happen next. Her question to the City Council was what the concerned citizens can do about it. She stated that she wants people to come to Lexington and be entertained, but not with the filth that is going on in that store. It was requested for permission to start a petition, and have it added as an Agenda Item for the next City Council meeting.

Nova Workman addressed the Lexington City Council stating that she went into the "BMT" (Adult Book Store), to see what was there, so she could talk about it. She stated that we have got to stop pornography, not only in BMT, but also in the other stores in town. The citizens elected the Council Members, and trust them to take care of our town and do what is right, and creating a City Code to prevent this would be the right thing.

Marcia Refior addressed the Lexington City Council inquiring as to the reason there is a gate at Memorial Park. Mayor Fagot stated that the traffic was an endangerment to the children playing there. Council Person Kohl added that there was a lot of traffic in the park late at night, and any business they had going on in the park that late at night, shouldn't be going on. Ms. Refior stated that her concern was handicap accessibility in the park. Mayor Fagot informed Ms. Refior that she can discuss this with Administration, and hopefully there could be a solution. Marcia also voiced her support for the beer garden.

Pastor Ralph Guetersloh, of Trinity Lutheran Church, addressed the Lexington City Council regarding the pornography book store. Pastor Guetersloh stated that he couldn't stand back and be silent. He stands before the Council as a person with moral objections to this. Pornography is a degenerative issue that breaks society down. He wants the Council to know that whatever direction they go, there are people who object to this kind of presence in the community.

Attorney Darrell Bryan addressed the Lexington City Council, on behalf of friends of "BMT". He has spoken with the owners to insure that they comply with all state and federal laws. His purpose in coming before the Council is to explain some of the practices and procedures of the store. First of all, no one under 21 gets in. Every person is I.D.'d and carded. Second, the windows of the store have purposely been tinted to avoid loitering. Third, the owners do not want to draw any attention to the store. They haven't put up any neon signs, or flashing lights. Basically, if you want to come into the store, you are welcome, but at the same time, you are also welcome to not come in if you disagree with their ideas.

Bill Ashmore, representing the Evangelical Free Church, addressed the Lexington City Council inquiring how the City is going to stop a minor from giving money to an adult to buy this stuff for them. He asks the Council to please pass the petition to prevent pornographic material in our City.

Jonathan Roos, Student Body President of Lexington High School, informed the Lexington City Council that he has many friends that drink even though it is against the law. Stores are suppose card people, but many times it doesn't happen. Pornography is very destructive and very addictive. He believes that many criminals may not have been led to commit the crimes they committed, had it not been for the access they had to those base materials. Lexington is known as being high in crime and also a dangerous place to live. Once you let in materials of a certain nature into a town, you're going to open up even more doors. He would like the Council to do all that is legally possible to stop the pornography from coming to town.

Mayor Fagot thanked the citizens for their opinions, and informed them that they will look at what information the citizens, administration, and legal counsel bring to them. Both Mayor Fagot and Council Person John Wightman informed the citizens that this item will be on the next agenda.

### LETTER OF SUPPORT:

Barb Vondras, member of the Scenic Management Committee, addressed the Lexington City Council, stating that they have the possibility of receiving a \$200,000 grant, that will be prorated out, for a scenic by-way between Overton and Sutherland along Highway 30. The state's commitment is that there would be markers put up, and maintained, every 8 to 10 miles. The Committee is asking for a letter of support from the City Council, and also from each Council Member by the end of June. Motion by Wightman, seconded by Klamm, to write a letter of support naming Highway 30 from Overton to Sutherland as a scenic by-way. City Attorney Weinhold informed Ms. Vondras and the City Council that one of the ramifications of the scenic by-way designation is control of outdoor advertising. This could possibly affect many billboards and other advertising structures in the area. Ms. Vondras stated that she would check into this. Roll call. Voting "aye" were Kohl, Cook, Klamm, Wightman, Fagot. Motion carried.

# SUBDIVISION PLAT:

Assistant City Manager Joe Pepplitsch presented the Lexington City Council with the Subdivision Plat for the Holiday Plaza. Mr. Pepplitsch stated that this is a standard subdivision agreement that shows an access easement along the frontage road. Parking spaces will be determined by the occupancy of the buildings per code. Moved by Cook, seconded by Klamm, to approve this form of the Subdivision

Agreement for the Holiday Plaza Subdivision. Roll call. Voting "aye" were Wightman, Kohl, Klamm, Cook, Fagot. Motion carried.

### **FIREWORKS PERMITS:**

City Manager Bricker informed the Lexington City Council that the expiration date of fireworks permits was put into place by the Legislature, and he is recommending that the City of Lexington follow State Law. The primary reason for this is for occupation tax. No action was required by City Council.

WEST CENTRAL NE AREA ON AGING CONTRACT: City Manager Bricker addressed the Lexington City Council stating that the West Central NE Area

on Aging Contract is an annual meals contract that comes before the Council that is entered into with the West Central Agency on Aging. This year, the contract showed an increase in funding to the Center, over previous years. The Grand Generation Center's Director, Ann Luther, informed the Council that the Center averages 150 meals per day. She further stated that the evening meal, that is served once a month, is doing well, as they get in a lot of younger seniors that are still working. They are hoping that when these people stop working, they will then take advantage of the noon meals. Moved by Wightman, seconded by Kohl, to accept the West Central NE Area on Aging Contract and authorize the Mayor to execute the contract. Roll call. Voting "aye" were Klamm, Cook, Kohl, Wightman, Fagot. Motion carried

MEMBERSHIP RESOLUTION:

City Manager Bricker addressed the Lexington City

Council stating that Council has already addressed, and has approved membership into the Energy Service Company. They had previously drafted a resolution on that. The resolution being brought before them now is the final resolution that was passed by ESCO. Following discussion regarding clarification of the timetable by the Lexington City Council, moved by Kohl, seconded by Wightman, to table the Membership Resolution with the Energy Services Company until the next Council meeting. Roll call. Voting "aye" were Klamm, Cook, Wightman, Kohl, Fagot. Motion carried.

**EXECUTIVE SESSION:** 

Moved by Wightman, seconded by Klamm, to recess the regular session into executive session at 8:37 p.m. to discuss personnel and the negotiation for the purchase of real estate. Roll call. Voting "aye" were Kohl, Cook, Klamm, Wightman, Fagot. Motion carried.

Moved by Wightman, seconded by Klamm, to reconvene the regular session from executive session at 9:28 p.m. Roll call. Voting "aye" were Kohl, Cook, Klamm, Wightman, Fagot. Motion carried.

**ADJOURNMENT:** 

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
