# **CITIZEN COMMENTS:**

Sharon Fellows addressed the Lexington City Council voicing her opinion on the loud music and parking problems in her neighborhood on Laramie Court. She stated that there is a band that practices next door to their home. Cars, belonging to band members parked in the area, create a problem getting in, and out, of the driveway for Ms. Fellows. The noise created by the band rattles her windows,

and doesn't allow her to open her doors. Mayor Fagot informed Ms. Fellows that there is due process, and that she would be required to file a complaint, and testify, should it go to Court.

#### FINANCIAL REPORT:

Financial Director Barb Mills, presented the Financial Report to the Lexington City Council, for the month of September, 2000. Following Ms. Mills' presentation, moved by Klamm, seconded by Wightman, to accept the Financial Report for September, 2000. Roll call. Voting "aye" were Cook, Kohl, Wightman, Klamm, Fagot. Motion carried.

# LEGISLATIVE REDISTRICTING:

DeEtta Hartman, Executive Director of Dawson Area Development, addressed the Lexington City Council, stating that the State Legislature will consider redistricting the State Legislative Districts due to the 2000 Census. It is being requested that the Lexington City Council pass a Resolution of Support to have Dawson County remain in one Legislative District, and not split the County into . Following discussion, and the reading of Resolution No. 00-23, moved by Wightman, seconded by Klamm, to adopt the following Resolution. Roll call. Voting "aye" were Kohl, Cook, Wightman, Klamm, Fagot. Motion carried.

### RESOLUTION 00 -23

A RESOLUTION OF THE MAYOR AND COUNCIL OF LEXINGTON, DAWSON COUNTY, NEBRASKA, REQUESTING THE CONSIDERATION THAT DAWSON COUNTY REMAIN AS A TOTAL UNIT OF A NEBRASKA LEGISLATIVE DISTRICT.

WHEREAS, State and Federal regulations require the redrawing of boundary lines following the United States decennial census to equalize district populations, and

WHEREAS, the Nebraska Legislature is in the process of a consideration of proposals for this redistricting and the passage of legislation this legislative session to approve said redistricting, and

WHEREAS, Dawson County including all the communities therein, have been a part of one legislative district for the purposes of providing the citizens of the Dawson County area equal and responsive representation, and

WHEREAS, through the efforts of the Dawson County Commissioners and the Mayors and Councils of Lexington, Cozad, and Gothenburg have formed the Dawson Area Development Corporation, uniting the progressive efforts for the economic well being of the Dawson County area, and

WHEREAS, citizens of the Dawson County community have benefited from this united effort and it is felt by the public officials that separation by legislative districts of any part of a Dawson County area would curtail and severely hinder the continued progressive economic growth of our area.

IT IS THEREFORE RESOLVED THAT THE MAYOR AND CITY COUNCIL OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, do hereby respectfully request the members of the Nebraska Legislature in their efforts to redistrict the legislative districts in the equalization of population to allow Dawson County and the communities therein to be part of one legislative district.
