He stated that the Change Order referred to the Fine Grading done. The City was responsible for the seeding. Moved by Klamm, seconded by Cook, to approve Change Order No. 1 for the Jefferson Street Project. Roll call. Voting "aye" were Tomasek, Salem, Cook, Klamm, Fagot. Motion carried.
