Voting "aye" were Klamm, Cook, Kohl, Wightman, Fagot. Motion carried.

WEST CENTRAL AREA AGENCY ON AGING:

City Manager Joe Pepplitsch addressed the Lexington City Council stating that approval is being requested to authorize the Mayor to sign West Central Area Agency on Aging's Operating Perpetual Contract for Center Meals and Operations for Fiscal Year 2001. He further stated that reimbursement went up slightly per meal served, and that the number of meals served has steadily increased by approximately 3% a year, since 1995. Following further discussion, moved by Wightman, seconded by Klamm, to approve the West Central Area Agency on Aging's Operating Contract for Center Meals and Operations for Fiscal Year 2001, and authorize the Mayor to sign said contract. Roll call. Voting "aye" were Cook, Kohl, Klamm, Wightman, Fagot. Motion carried.

FINANCIAL REPORT:

Financial Director Barbara Mills presented the Lexington City Council with the Financial Report for May, 2000. Following Ms. Mills presentation, and further discussion, moved by Klamm, seconded by Wightman, to approve accept the Financial Report for May, 2000. Roll call. Voting "aye" were Kohl, Cook, Wightman, Klamm, Fagot. Motion carried.

CRA APPOINTMENT:

City Manager Joe Pepplitsch addressed the Lexington City Council stating that there had recently been a vacancy on the CRA Board by Clark Cunningham, and that Wes Lubberstedt agreed to fill the vacant position upon approval by the City Council. Moved by Wightman, seconded by Klamm, to approve the appointment of Wes Lubberstedt to fill the vacancy left by Clark Cunningham, on the Community Redevelopment Authority Board. Roll call. Voting "aye" were Kohl, Cook, Klamm, Wightman, Fagot. Motion carried.

LASWA REPRESENTATIVE:

City Manager Joe Pepplitsch stated that upon the retirement of former City Manager Vance Bricker, a new representative would need to be appointed to the Lexington Area Solid Waste Agency Board. Approval is requested to have City Manager Pepplitsch appointed as Representative, and Glenn Hawks appointed as Alternate Representative to represent Lexington on the LASWA Board. Following further discussion, moved by Klamm, seconded by Kohl, that the following Resolution be passed and approved. Roll call. Voting "aye" were Cook, Wightman, Kohl, Klamm, Fagot. Motion carried.
