PUBLIC HEARING:

Mayor Fagot opened the Public Hearing. Mike Bacon, attorney representing the CRA, introduced Keith Sladky, who is the Administrator of Plum Creek Care Center. Mr. Sladky reviewed the plans for expansion and remodeling the Care Center. Following Mr. Sladky's presentation, Mr. Bacon explained the TIF Financing for this project, as well as Infrastructure Plans. He further stated that the total cost of the project will be \$1.4 Million. Following Mr. Bacon's

presentation, and discussion by the Citizens and Council, Mayor Fagot closed the Public Hearing.

RESOLUTION:

A Resolution was read before Council. Moved by Klamm, seconded by Tomasek, to approve Resolution Number 01-14 as presented, and authorize the Mayor to execute required documents. Roll call. Voting "aye" were Salem, Cook, Tomasek, Klamm, Fagot. Motion carried.

RESOLUTION - 01-14

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, APPROVING A REDEVELOPMENT PLAN AS CONTAINED IN A REDEVELOPMENT CONTRACT AND MAKING FINDINGS WITH REGARD TO SUCH PLAN.

WHEREAS, the City of Lexington, Nebraska a municipal corporation has determined it to be desirable to undertake and carry out urban redevelopment projects in areas of the City which are determined to be substandard and blighted and in need of redevelopment; and

WHEREAS, the Nebraska Community Development Law, Chapter 18, Article 21, Nebraska Reissue Revised Statutes of 1943, as amended (the "Act"), prescribes the requirements and procedures for the planning and implementation of redevelopment projects; and

WHEREAS, The City has previously declared an area of the City to be substandard and blighted and in need of redevelopment pursuant to the Act; and

WHEREAS, The Community Redevelopment authority of the City of Lexington, Nebraska (the "Authority"), has prepared a Redevelopment Plan as contained in a Redevelopment contract [Lantis Enterprises, Inc., Contract dated August 28, 2001] pursuant to Section 18-2111 of the Act; and

WHEREAS, the Lexington Planning Commission reviewed the Redevelopment Plan pursuant to the Act and, pursuant to Section 18-2114 of the Act, recommended approval of the Redevelopment plan to the City; and

WHEREAS, following consideration of the recommendations of the Planning Commission to the City, the Mayor and City Council held a public hearing on August 28, 2001, pursuant to notice as required by law; and

WHEREAS, there has been presented for approval a specific Redevelopment Project and Redevelopment Plan, as prescribed in the Redevelopment Contract;

NOW, THEREFORE, be it resolved by the Mayor and City Council of the City of Lexington, Nebraska:

- The Redevelopment Plan as contained in the Redevelopment contract in the form attached to this Resolution as Exhibit A is hereby determined to be feasible and in conformity with the general plan for the development of the City of Lexington as a whole and the Redevelopment Plan is in conformity with the legislative declarations and determinations set forth in the Act;
- 2. The Mayor and City Council specifically find, as follows:

- (a) The project described in the redevelopment contract and plan attached thereto, would not be economically feasible without the use of tax-increment financing;
- (b) The project would not occur in the Redevelopment Area without the use of tax-increment financing; and
- (c) The costs and benefits of the Project, including costs and benefits to other affected political subdivisions, the economy of the community, and the demand for public and private services have been analyzed by the governing body and have been found to be in the long term best interests of the community impacted by the project.
- Approval of the Redevelopment Plan is hereby ratified and reaffirmed and the Authority is hereby directed to implement the Redevelopment Plan in accordance with the Act.
- 4. Pursuant to Section 18-2147 of the Act, any ad valorem tax levied upon real property in the redevelopment project specified in the plan, namely;

All of Westside Home Addition to the City of Lexington, Dawson County, Nebraska; and

A tract of land in the SE1/4 of Section 31, Township 10 North, Range 21, West of the 6th P.M., Dawson County, Nebraska, and more particularly described as follows: Beginning at a point which is 673 feetNorth and 333 feet West of the Southeast corner of the SE1/4 of Section 31, Township 10 North, Range 21 West of the 6th P.M.; thence North, and parallel to the East line of said SE1/4 a distance of 824 feet to a point which is 17 feet South of the center line of 17th Street extended; thence North 89°10' West a distance of 30 feet; thence South and parallel to the East line of said SE1/4 a distance of 824 feet; thence South 89°42' East a distance of 30 feet to the place of beginning; and

A tract of land in the E1/2 of the SE1/4 of Section 31, Township 10 North, Range 21 West of the 6th P.M., Dawson County, Nebraska and more particularly described as follows: referring to the Southeast corner of Section 31, Township 10 North, Range 21 West of the 6th P.M., Dawson County, Nebraska; thence North and along the East section line of said Section 31 a distance of 703.0 feet; thence N 89°42' W, and along the North line of 15th Street, a distance of 363.0 feet to the Point of Beginning; said point is also the Southeast corner of Lot 1, Block 1, Woodwards First Addition to the City of Lexington, Dawson County, Nebraska; thence N 89°42' W, and along the South line of said Block 1, Woodwards First Addition, a distance of 20.0 feet; thence North, and parallel with the East section line of said Section 31, a distance of 794-7 feet; thence East, and parallel with the North line of said Block 1, Woodwards First Addition, a distance of 20.0 feet; thence South, and parallel with the East section line of said Section 31, a distance of 794.8 feet to the place of beginning, as surveyed, platted and recorded, now being a part of the City of Lexington, all in Dawson County, Nebraska, shall be divided, for the period not to exceed 15 years after the effective date of the provision, which effective date shall be January 1, 2002.

- a. That portion of the ad valorem tax which is produced by levy at the rate fixed each year by or for each public body upon the redevelopment project valuation shall be paid into the funds of each such public body in the same proportion as all other taxes collected by or for the bodies; and
- b. That portion of the ad valorem tax on real property in the redevelopment project in excess of such amount, if any, shall be allocated to and, when

collected, paid into a special fund of the Authority to pay the principal of, the interest on, and any premiums due in connection with the bonds, loans, notes, or advances on money to, or indebtedness incurred by, whether funded, refunded, assumed, or otherwise, such authority for financing or refinancing, in whole or in part, a redevelopment project. When such bonds, loans, notes, advances of money, or indebtedness including interest and premium due have been paid, the Authority shall so notify the County Assessor and County Treasurer and all ad valorem taxes upon real property in such redevelopment project shall be paid into the funds of the respective public bodies.

- The Mayor is directed to execute and deliver to the County Treasurer and Assessor, the Notice of Allocation of Taxes which is attached hereto and marked as exhibit B.
- 6. The Bond mentioned in section 18-2151 R.R.S. 1997, is not required.

CODE OFFICER:

Pepplitsch addressed the City Council on partial funding for an additional drug investigator for the Lexington/Dawson County area. He does not anticipate that it would exceed \$5,000 per year. Roll call. Voting "aye" were Salem, Tomasek, Cook, Klamm, Fagot. Motion carried.

NEBESCO MEMBERSHIP:

Pepplitsch addressed the City Council regarding continued membership in the Nebraska Energy Services Company. He recommended that the City of Lexington decline continued membership. Following discussion, moved by Klamm, seconded by Salem, to direct Administration to withdraw membership from Nebraska Energy Services Company. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

OWNER-OCCUPIED HOUSING REHABILITATION PROGRAM:

Pepplitsch addressed the City Council requesting adoption of the Policies and Guidelines for Owner-Occupied Housing Rehabilitation Program, for administering the Housing Rehabilitation Program. Following discussion, moved by Klamm, seconded by Tomasek, to adopt the Policies and Guidelines for Owner-Occupied Housing Rehabilitation Program, as presented. Roll call. Voting "aye" were Salem, Cook, Tomasek, Klamm, Fagot. Motion carried.

REUSE PLAN FOR PROGRAM INCOME OF CDBG #01-HO-303: Pepplitsch addressed the City Council, on a reuse plan for CDBG #01-HO-303. Following discussion, moved by Klamm, seconded by Salem, to adopt the Reuse Plan for Program Income of CDBG #01-HO-303. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

5TH & JACKSON TRAFFIC **CONTROL:**

Pepplitsch addressed the City Council, requesting discussion on the traffic control options at the intersection of 5th & Jackson Streets. The No-Left Turn Sign was initially installed when UPRR's third rail was being installed, and all crossings were closed for the construction. Installing the sign helped to alleviate some of the congestion. Rod Streff, owner of S & W Auto Parts, addressed the Council, stating his concern of the traffic control and the effect on his business. Following discussion, Council recommended that a Resolution be prepared to request the State of Nebraska remove the No-Left Turn Sign at the intersection of 5th and

Jackson.

FINANCIAL REPORT: The Financial Report for July, 2001 was presented to Council for acceptance.

> Following discussion, moved by Klamm, seconded by Tomasek, to accept the Financial Report for July, 2001. Roll call. Voting "ave" were Cook, Salem.

Tomasek, Klamm, Fagot. Motion carried.

LIQUOR LICENSE: There being no one present to represent Lo Mejor de Michoacan, this Item was

tabled until the next Council meeting which is scheduled for Tuesday, September

11, 2001.

ADJOURNMENT: There being no further business to come before the Council, Mayor Fagot

declared the meeting adjourned.
