PUBLIC HEARING:

Mayor Fagot opened the Public Hearing. Irma Flores, representing El-Tequila, addressed the City Council, stating that she just received notice that the Class "I" Liquor License, that she has applied for is not available in the City of Lexington, and is therefore requesting the Council approve amending her application to a Class "M" License. Following discussion, Mayor Fagot closed the Public Hearing. Moved by Cook, seconded by Tomasek, to request the Liquor License Application for Irma I. Flores, dba "El-Tequila", located at 2307 Plum Creek Parkway, Lexington, NE 68850 be corrected to a Class "M" License, and presented again to Council in the proper form. Roll call. Voting "aye" were Klamm, Salem, Tomasek, Cook, Fagot. Motion carried.

BOND RESOLUTION:

Pepplitsch addressed the City Council, requesting their approval of a Resolution directing the issuance of a Bond to fund the Lexington Economic Development Fund. Following discussion, a Resolution entitled "A RESOLUTION OF THE CITY OF LEXINGTON, NEBRASKA, AUTHORIZING THE ISSUANCE OF ECONOMIC DEVELOPMENT FUND SALES TAX BOND OF THE CITY OF LEXINGTON, NEBRASKA, IN THE PRINCIPAL AMOUNT OF SEVEN HUNDRED FIFTY THOUSANT DOLLARS (\$750,000) FOR THE PURPOSE OF FUNDING THE LEXINGTON ECONOMIC DEVELOPMENT **PROGRAM** AS **ESTABLISHED** ORDINANCE NO. 2123 OF THE CITY; PRESCRIBING THE FORM OF SAID BOND; PROVIDING FOR THE PLEDGING OF SALES TAX COLLECTIONS RECEIVED FOR SAID PROGRAM INTO

THE ECONOMIC DEVELOPMENT FUND OF THE CITY OF LEXINGTON FOR THE PAYMENT OF PRINCIPAL AND INTEREST ON SAID BOND; PROVIDING FOR A PLEDGE OF **CERTAIN REVENUES:** PROVIDING FOR **CERTAIN** COVENANTS FOR THE PROTECTION OF THE HOLDER OF SAID BOND; PROVIDING FOR THE SALE OF THE BOND; PROVIDING FOR THE APPLICATION OF THE PROCEEDS OF SAID BOND; AND AUTHORIZING THE DELIVERY OF THE BOND TO THE PURCHASER" was read before Council. Moved by Klamm, seconded by Salem, to approve Resolution Number 02-02 as presented, and authorize proper signatures on said documents. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

PUBLIC HEARING:

Mayor Fagot declared the Public Hearing open. Mike Bacon, representing the Community Redevelopment Authority, presented the City Council with the proposed Redevelopment Plan for Redevelopment Area #2. Following Mr. Bacon's presentation, Mayor Fagot closed the Public Hearing. No action was taken.

RESOLUTION:

A Resolution entitled "RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LEXINGTON; APPROVING A REDEVELOPMENT PLAN; MAKING FINDINGS WITH REGARD TO SUCH PLAN AND APPROVING OTHER ACTION THEREON" was read before the Council. Moved by Klamm, seconded by Tomasek, to approve Resolution 02-03 as amended. Roll call. Voting "aye" were Salem, Cook, Tomasek, Klamm, Fagot. Motion carried.

EASEMENT RELEASE:

Pepplitsch presented the City Council with a request for the release of an easement associated with Spring Creek Watershed on land described as Section 28, Township 14 North, Range 24 West of the 6th P.M., in Custer County, Nebraska. Following discussion, moved by Klamm, seconded by Tomasek, to table the request indefinitely, and direct Administration to bring back to Council should anything pertinent arise. Roll call. Voting "aye" were Cook, Salem, Tomasek, Klamm, Fagot. Motion carried.

COUNCIL COMPENSATION:

Mayor Fagot presented the City Council with an Ordinance to set compensation levels of City Council Members. Following discussion, an Ordinance entitled "AN ORDINANCE TO AMEND SECTION 2-10 OF THE LEXINGTON CITY CODE; TO AMEND THE ANNUAL SALARY FOR MEMBERS OF THE CITY COUNCIL AND THE PRESIDENT OF THE CITY COUNCIL; TO REPEAL ORIGINAL SECTION 2-10 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before the Council. Moved by Tomasek, seconded by Klamm, to approve said Ordinance on First Reading. Roll call. Voting "aye" were Klamm, Tomasek, Fagot. Voting "nay" were Cook, Salem. Motion carried.

EXECUTIVE SESSION:

Moved by Klamm, seconded by Tomasek, to enter into Executive Session at 7:52 p.m. Roll call. Voting "aye" were Cook, Salem, Tomasek, Klamm, Fagot. Motion carried.

Moved by Salem, seconded by Tomasek, to reconvene Regular Session from Executive Session at 8:40 p.m. Roll call. Voting "aye" were Klamm, Cook, Tomasek, Salem, Fagot. Motion carried.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
