Bo has earned his Eagle Badge through a local Boy Scout Troop by constructing an Announcement Board for the Tennis Courts at Plum Creek Park. **JAKE BRAKES:** Following discussion prohibiting Jake Braking in the City limits, an Ordinance entitled "AN ORDINANCE TO AMEND SECTION 17-3 THE LEXINGTON CITY CODE; TO PROHIBIT OF JAKEBRAKING BY SEMITRACTORS AS AN UNNECESSARY NOISE; TO REPEAL ORIGINAL SECTION 17-3 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before the Council. Said Ordinance was read by Title. Moved by Klamm, seconded by Salem, to approve Ordinance Number 2155 on Final Reading. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried. SUBDIVISION Pepplitsch addressed the City Council requesting approval of Subdivision Agreement for Fertitta Addition. Following discussion, **AGREEMENT:** moved by Klamm, seconded by Tomasek, to approve the Subdivision Agreement for Fertitta Addition, and authorize signatures on said documents. Roll call. FINANCIAL REPORT:	Pepplitsch presented the Council with the Financial Report for March, 2002. Following discussion, moved by Klamm, seconded by Tomasek, to accept the Financial Report for March, 2002. Roll call. Voting "aye" were Cook, Salem, Tomasek, Klamm, Fagot. Motion carried.
