Moved by Cook, seconded by Klamm, to recommend approval of a Class "M" Liquor License Application for LeLe Inc., dba Lakota, located at 405 N. Washington, Lexington, NE 68850. Roll call. Voting "aye" were Tomasek, Salem, Klamm, Cook, Fagot. Motion carried.

RESOLUTION:

Pepplitsch addressed the City Council requesting approval of a resolution establishing a street improvement district on 14th Street from Jefferson to Tyler Streets. Following discussion, moved by Klamm, seconded by Salem, to approve Resolution No. 02-06. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

RESOLUTION NO. 02-01

A RESOLUTION CREATING IMPROVEMENT DISTRICT NO. 02-01, PROVIDING FOR GRADING, CONCRETE PAVING, CURB AND GUTTER, AND DRAINAGE THEREIN.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. Pursuant to the authority granted by Nebraska Revised Statutes Sections 18-2001 through 18-2003, the Council finds that 14th Street, between Tyler and Jefferson Streets, constitutes an unpaved gap between otherwise paved streets, and there is hereby created within the City of Lexington, an Improvement District to be known as "Improvement District No. 02-01".

Section 2. The Improvement District shall consist of the following streets or portions of streets in the City of Lexington, Nebraska:

14th Street, from Tyler Street to Jefferson Street

- Section 3. There shall be constructed and provided on the above described streets, grading, paving and drainage which shall be in accordance with the plans, specifications, and estimates to be hereinafter adopted.
- Section 4. The streets provided in the above section will abut on curb and gutter where it exists, and will include curb and gutter where curb and gutter has not already been provided.
- Section 5. That the cost of such grading, paving and drainage except street and alley intersections, shall be assessed against lots and tracts of land abutting upon and adjacent to said portion of the streets, specifically benefited thereby, in proportion to the benefit received, to be determined by the City Council as the law provides.

Following discussion, moved by Klamm, seconded by Salem, to set May 11, 2002 at 8:00 a.m. as the date and time for the City Council's Project Planning Session. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

EXECUTIVE SESSION:

Moved by Klamm, seconded by Salem, to go into executive session at 8:02 p.m. to discuss City Manager's Annual Evaluation. Roll call. Voting "aye" were Tomasek, Cook, Salem, Klamm, Fagot. Motion carried.

Moved by Salem, seconded by Klamm, to reconvene regular session from executive session at 8:40 p.m. Roll call. Voting "aye" were Cook, Tomasek, Klamm, Salem, Fagot. Motion carried.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
