John Wightman, representing Gene and Virginia Hokom, addressed the City Council, requesting their approval of a Waiver of Objection, on property generally described as Lot 21 of Jil-Mar Subdivision, Lexington, Nebraska. Following discussion, moved by Klamm, seconded by Salem, to approve the Waiver of Objection on property owned by Gene and Virginia Hokom, and generally described as Lot 21 of the Jil-Mar Subdivision, Lexington, Nebraska, and authorize execution of said document. Roll call. Voting "aye" were Tomasek, Cook, Salem, Klamm, Fagot. Motion carried.

BOND RESOLUTION:

Jim Fox, representing Ameritas Investment Corporation, addressed the City Council, requesting their approval of a resolution calling the Series 1997 General Obligation Bonds. Following Mr. Fox's presentation, moved by Klamm, seconded by Cook, to approve Resolution Number 02-11 calling the Series 1997 General Obligation Bonds.

BE IT RESOLVED by the Mayor and City Council of the City of Lexington, Nebraska: for payment on August 1, 2002, after which date interest on the bonds will cease:

Section 1. The following bonds, in accordance with their option provisions are hereby called for payment on August 1, 2002, after which date interest on the bonds will cease:

Various Purpose Bonds, Series 1997, of the City of Lexington, Nebraska, date of original issue – May 15, 1997, in the principal amount of One Million Five Hundred Thirty-five Thousand Dollars (\$1,535,000), numbered as shown on the books of the Paying Agent and Registrar, in denomination of \$5,000 each, becoming due and bearing interest as follows:

Said bonds are herinafter referred to as the "1997 Refunded Bonds."

Said bonds are subject to redemption at any time on or after May 15, 2002, at par and accrued interest, and said interest is payable semiannually. Said bonds were authorized by ordinance and were issued for the purpose of paying the costs of street improvements in Street Improvement District Nos. 94-03 and 9602; paying the cost of storm water sewer improvements in Storm Sewer District Nos. 94-04 and 9601; and paying and redeeming \$665,000 of the City's outstanding Various Purpose Bonds, Date of Original Issue – August 1, 1991.

Section 2. The 1997 Refunded Bonds are to be paid off at the office of the Treasurer of the City of Lexington, Nebraska, as paying agent and registrar.

Section 3. A true copy of this resolution shall be filed immediately with the Treasurer of the City of Lexington, Nebraska, as Paying Agent and Registrar for the 1997 Refunded Bonds, and said Paying Agent and Registrar is hereby instructed to mail notice to each registered owner of said bonds not less than thirty days prior to the date fixed for redemption, all in accordance with the ordinance authorizing the 1997 Refunded Bonds.

Moved by Klamm, seconded by Salem, to suspend the rules requiring the reading of said ordinance on three separate days. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

Said Ordinance was read by Title. Moved by Klamm, seconded by Tomasek, to approve Ordinance Number 2159 on Final Reading. Roll call. Voting "aye" were Salem, Cook, Tomasek, Klamm, Fagot. Motion carried.

PUBLIC HEARING:

Mayor Fagot opened the Public Hearing. Pepplitsch addressed the City Council, stating that the Citizen Advisory Review Committee reviewed the Lexington Economic Development Program, and found everything to be in order. Following Pepplitsch's report, Mayor Fagot closed the Public Hearing. Moved by Klamm, seconded by Tomasek, to accept the report from the Citizen Advisory Review Committee. Roll call. Voting "aye" were Cook, Salem, Tomasek, Klamm, Fagot. Motion carried.

Pepplitsch addressed the City Council requesting their approval of a proposal for engineering services from Olsson Associates for the construction of the 15 MVA Electric Substation. Following discussion, moved by Klamm, seconded by Salem, to approve the proposal for engineering services from Olsson Associates for the construction of the 15 MVA Electric Substation, and authorize the Mayor, and/or City Administration to sign the necessary documents. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

DAD APPOINTMENT:

Mayor Fagot announced that John Wightman currently serves on the Dawson Area Development Board, and his term has expired, therefore, Mayor Fagot would like to nominate John Wightman for reappointment to the Board. Following discussion, moved by Salem, seconded by Klamm, to reappoint John Wightman as a Board Member of the Dawson Area Development. Roll call. Voting "aye" were Tomasek, Cook, Klamm, Salem, Fagot. Motion carried.

FINANCIAL REPORT: Pepplitsch addressed the City Council reviewing the Financial Report

for May, 2002. Following discussion, moved by Klamm, seconded by Tomasek, to accept the Financial Report May, 2002. Roll call. Voting "aye" were Salem, Cook, Tomasek, Klamm, Fagot. Motion carried.

ADJOURNMENT: There being no further business to come before the Council, Mayor

Fagot declared the meeting adjourned.
