Pepplitsch requested Council's approval of an Ordinance regulating Billboards in the City of Lexington's Zoning Jurisdiction. Following discussion, an Ordinance entitled "AN ORDINANCE TO PROVIDE REGULATION OF BILLBOARDS; TO AMEND SECTION 28-30.9

OF THE LEXINGTON CITY CODE; TO REPEAL ORIGINAL SECTION 28-30.9 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO DECLARE AN EMERGENCY AND PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before Council. Moved by Klamm, seconded by Tomasek, to suspend the rules requiring the reading of said ordinance on three separate days. Roll call. Voting "aye" were Cook, Salem, Tomasek, Klamm, Fagot. Motion carried.

Said Ordinance was read by title. Moved by Klamm, seconded by Salem, to approve Ordinance No. 2175 on Final Reading. Roll call. Voting "aye" were Tomasek, Cook, Salem, Klamm, Fagot. Motion carried.

## MAIN STREET DISTRICT LIGHTING:

Pepplitsch requested Council's approval of a Resolution approving the Agreement with the State Department of Roads, to install historical lighting in the Lexington Main Street District. Following discussion, Resolution was read. Moved by Klamm, seconded by Salem, to approve Resolution No. 03-19. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

## RESOLUTION NO. 03-19

WHEREAS, the City of Lexington wishes to enter into an agreement with the State of Nebraska Department of Roads to install historical lighting in the Lexington Main Street District, with funds made available through STP Enhancement Program funds, and

WHEREAS, the Federal share payable shall be a maximum of fifty-four (54%) percent of the eligible costs thereof, up to a maximum payment from federal funds of \$30,000.00, and

WHEREAS, the City of Lexington shall be responsible for approximately \$25,610.00, which is estimated by the City to be the City's forty-six (46%) percent matching share of eligible project costs, and

WHEREAS, the City of Lexington has agreed to place in its fiscal budget said amount,

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, that the City enter into an agreement with the State of Nebraska Department of Roads for the installation of historical lighting in the Lexington Main Street District; that this project be constructed under the designation of Project Number STPB 24(35), State Control No. 61353, and that the terms and conditions as contained in the Agreement with the Nebraska Department of Roads are hereby approved and that the Mayor is hereby authorized to execute said Agreement.
