ORDINANCE:

Mayor Fagot addressed the City Council presenting them with an Ordinance restricting parking in residential use areas. Following extensive discussion regarding refining ordinance, moved by Cook, seconded by Klamm, to table this item, until the May 13, 2003 City Council Meeting. Roll call. Voting "aye" were Salem, Tomasek, Klamm, Cook, Fagot. Motion carried.

FINANCIAL REPORT:

Pepplitsch addressed the City Council presenting them with the Financial Report for March, 2003. Following discussion, moved by Salem, seconded by Klamm, to accept the Financial Report for March, 2003. Roll call. Voting "aye" Tomasek, Cook, Klamm, Salem, Fagot. Motion carried.

LEXINGTON FACILITIES CORPORATION:

Mayor Fagot addressed the City Council requesting their approval of the creation of the Lexington Facilities Corporation. Following discussion, moved by Cook to disallow the creation of the Lexington Facilities Corporation. Motion died for lack of a second. Moved by Klamm, seconded by Tomasek, to approve the articles of incorporation of the Lexington Facilities Corporation in their form, with the actual incorporation to take place at a later date. Roll call. Voting "aye" were Salem, Tomasek, Klamm, Fagot. Voting "nay" was Cook. Motion carried.

ROUNDTABLE DISCUSSION:

Pepplitsch addressed the City Council presenting them with a memo from the Lexington Fire Department, noting that Mr. Ron Leibhart had resigned from the Department. It was requested that a new Roster be presented to Council for consideration at the next City Council Meeting.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
