Tim Keelan representing Hanna:Keelan Associates, presented the City Council with the recently completed Lexington Housing Survey. Following Mr. Keelan's presentation, Pepplitsch addressed the Council on Economic Development planning and issues. Following discussion, Pepplitsch requested the Council's position on policy for the City to move forward, and what role the City should have in housing and economic development activities. Emphasis was placed on cooperation and organized efforts of the City and other interest groups. Council directed Administration to draft a structure on Economic Development, and Housing activities for further Council consideration.
