PUBLIC HEARING:

Mayor Fagot opened the Public Hearing. Mr. Clinton Witt requested Council's approval of an Ordinance rezoning his property located at 3033 Plum Creek Parkway, from A-1 to C-3. Following discussion, Mayor Fagot closed the Public Hearing. An Ordinance entitled "AN ORDINANCE TO REZONE A TRACT OF LAND IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 20, TOWNSHIP 9 NORTH, RANGE 21 WEST OF THE 6TH P.M. IN DAWSON COUNTY, NEBRASKA FROM A-1

AGRICULTURAL DISTRICT TO C-3 HIGHWAY COMMERCIAL DISTRICT; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before Council. Said Ordinance was read by title. Moved by Klamm, seconded by Salem, to approve Ordinance No. 2181 on Final Reading. Roll call. Voting "aye" were Tomasek, Cook, Salem, Klamm, Fagot. Motion carried.

PUBLIC HEARING:

Mayor Fagot opened the Public Hearing. Mr. Clinton Witt requested Council's approval of a Special Use Request on his property located at 3033 Plum Creek Parkway, to accommodate a Camping Trailer Park. Following discussion, Mayor Fagot closed the Public Hearing. Council directed Legal Counsel to draft a Special Use Permit Agreement that City Council deemed applicable to Mr. Witt's Special Use Request, and present it at the next regular City Council Meeting.

HOUSING AUTHORITY:

Lexington Housing Authority's Executive Director, Diane Adams, presented a report to Council, on the purpose of the Lexington Housing Authority, as well as, the various programs offered. Upon completion of Ms. Adams presentation, Council expressed their appreciation for her work on the Lexington Housing Authority.

COMMUNITY DEVELOPMENT:

Bob Heinz, Chairman of CED, presented a Power Point presentation to Council, on concepts for cooperative community development efforts. Items discussed included a mission, a task force, and roles within each entity in the community plays. Following Mr. Heinz's presentation, Council reported that they will take the CED's presentation under advisement.

Pepplitsch requested Council's approval of a Resolution to amend the Interlocal Agreement with the Dawson County Mutual Finance Organization. Following discussion, Resolution was read before Council. Moved by Klamm, seconded by Salem, to approve Resolution No. 04-07. Roll call. Voting "aye" were Cook, Tomasek, Salem, Klamm, Fagot. Motion carried.

RESOLUTION NO. 04-07

RESOLUTION TO AMEND INTERLOCAL AGREEMENT DAWSON COUNTY MUTUAL FINANCE ORGANIZATION

WHEREAS, the undersigned is a member of the Dawson County Mutual Finance Organization, which by the terms of the original Agreement will terminate June 30, 2004, unless such Agreement is amended; and

WHEREAS, the undersigned desires to perpetuate said Dawson County Mutual Finance Organization and remain a member of the same.

BET IT THEREFORE RESOLVED, that Paragraph 5 of the INTERLOCAL AGREEMENT CREATING THE DAWSON COUNTY MUTUAL FINANCE ORGANIZATION, be amended to read as follows:

5. This Agreement shall become effective April 12, 2000, and upon the signing of the Agreement by the parties and shall remain in effect until June 30, 2004, unless sooner terminated by mutual agreement of the parties. Any party to this Agreement may withdraw from the Agreement by serving notice of withdrawal by U.S. Mail to the Secretary of the Mutual Finance Organization Board, prior to April 1of each year.

BE IT FURTHER RESOLVED that the undersigned entity desires to continue membership and participation in said Mutual Finance Organization.
