ALL HAZARD MITIGATION PLAN:

This being the second public meeting held regarding Lexington's All Hazard Mitigation Plan, Mr. Steve McMaster, representing the Department of Natural Resources, presented those in attendance with a Draft Report compiled by his office. Items discussed and presented by Mr. McMaster included the following: Structural Inventory of Lexington, Flooding Background, Flood Vulnerability, Flood Mitigation Projects, Clean and Grub Spring Creek, Levee and Retention/Detention, Floodproofing Infrastructure, Flood Plain Regulations, Flood Insurance, Public Education, Tornado Background, Tornado Vulnerability, Potential Tornado Projects, Summer Storm Background, Summer Storm Vulnerability, Potential Severe Storm Projects, Winter Storm Background, Potential Winter Storm Projects, Economic Disaster, Economic Vulnerability. Input by the public included the following, which has been prioritized: Flood Plain Mapping, Awareness Programs for Severe Weather which would also be available in Spanish, and Identifying Storm Structures. McMaster reported that he will finalize the draft report, and submit to FEMA. Following FEMA's review, it will then be presented to Council for their consideration.

PAY REQUEST:

Pepplitsch requested Council's approval of Pay Request No. 11 for the Lexington Public Library Project. Following discussion, moved by Tomasek, seconded by Bennett, to approve Pay Request No. 11 for the Lexington Public Library Porject, to Lacy Construction Co., in the amount of \$132,724.35. Roll call. Voting "aye" were Fagot, Miller, Bennett, Tomasek, Cook. Motion carried.

CITY MAINTENANCE RENEWAL:

Pepplitsch requested Council's approval of a Maintenance Agreement between the City of Lexington, and the Nebraska Department of Roads. Following discussion, moved by Miller, seconded by Fagot to approve the Maintenance Renewal Agreement between the City of Lexington and the Nebraska Department of Roads. Roll call. Voting "aye" were Tomasek, Bennett, Fagot, Miller, Cook. Motion carried.

REAL ESTATE PURCHASE AGREEMENT:

Pepplitsch requested Council's approval of a Purchase Agreement between the City of Lexington and Dawson County School District No. 1, for a House located at 1006 N. Washington, and the current Library Facility located at 103 East 10th Street. Following discussion, moved by Fagot, seconded by Miller, to approve the Purchase Agreement between the City of Lexington and Dawson County School District No. 1. Roll call. Voting "aye" were Bennett, Tomasek, Miller, Fagot, Cook, Motion carried.

ORDINANCE:

Following discussion, an Ordinance entitled "AN ORDINANCE DIRECTING THE SALE OF OLD LIBRARY PROPERTY; TO PROVIDE FOR PUBLICATION AND THE RIGHT OF REMONSTRANCE", was read before Council. Moved by Fagot, seconded by Tomasek, to suspend the rules requiring the reading of said ordinance on three separate days. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Fagot, Cook. Motion carried.

Said Ordinance was read by title. Moved by Fagot, seconded by Miller, to approve Ordinance No. 2203 on Final Reading. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Fagot, Cook. Motion carried.

SUMMIT REPORT:

Discussion was held regarding the Community and Economic Development Summit Report, which on June 28, 2005, Council had forwarded on to the Community Development Advisory Board for review. Mayor Cook reported that during a discussion with City Attorney Weinhold, there were many questions raised, and because of that he would like the Report rescinded from the CDAB, and sent back to the Economic Development Summit Committee. Councilman Fagot stated that he would like the CDAB to continue to review the Report. Following discussion, moved by Cook, seconded by Miller, to rescind the Community and Economic Development Summit Report from the CDAB, and send it back to the Economic Development Summit Committee for revision. Roll call. Voting "aye" were Bennett, Miller, Cook. Voting "nay" were Tomasek and Fagot. Motion carries.

ROUNDTABLE DISCUSSION:

Pepplitsch reported that the first 2005-2006 Budget Workshop for the City of Lexington is scheduled for 12:00 p.m. August 10, 2005. Future Budget Workshops will be scheduled at that meeting.

Councilman Fagot expressed his concern regarding the image of Lexington, and that the recent luncheon meeting held for Governor Heineman at the Holiday Inn Express reflected poorly on the community. Comments were made by various people to Councilman Fagot, regarding how the meeting had been orchestrated to meet some personal agendas, and that some dignitaries in attendance were ignored, which was disrespectful and discourteous. Fagot further stated that if the community of Lexington is going to be improved, they need to be led by example. He had received apologies from the Chamber of Commerce because they feel they were in error in some of the things that were done. Mayor Cook responded by stating that Councilman Fagot's comments are out of line, that the Chamber of Commerce did a wonderful job putting the luncheon on, and it was well attended.

ADJOURNMENT:

There being no further business to come before Council, Mayor Cook declared the meeting adjourned.
