Mrs. Audrey Albright addressed the City Council regarding fence issues on the north and south side of her property, which is located at 1406 N. Washington. Visual obstruction on the south side of her property was the source of concern for Mrs. Albright. Following her comments, Mrs. Albright requested a response to her concerns in the near future.

TAX REQUEST RESOLUTION: Mayor Cook opened the Public Hearing. Following discussion, a Resolution entitled "A RESOLUTION SETTING THE PROPERTY TAX REQUEST FOR FISCAL YEAR 2005-2006 AT A DIFFERENT AMOUNT THAN THE PRIOR YEAR" was read before Council. Following discussion, Mayor Cook closed the Public Hearing. Moved by Fagot, seconded by Miller, to approve Resolution No. 05-21, setting the property tax request for fiscal year 2005-2006 at a different amount than the prior year. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Fagot, Cook. Motion carried.

RESOLUTION NO. 05-21

A RESOLUTION SETTING THE PROPERTY TAX REQUEST FOR FISCAL YEAR 2005-2006 AT A DIFFERENT AMOUNT THAN THE PRIOR YEAR.

WHEREAS, the Nebraska Revised Statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the City of Lexington passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interests of the Municipality that the property tax request for the current year be a different amount than the property tax request for the prior year.

NOW, THEREFORE, the Governing Body of the City of Lexington by a majority vote, resolves that:

- 1. The 2005-2006 property tax request be set at \$523,245.06.
- 2. A copy of this resolution shall be certified and forwarded to the County Clerk prior to October 13, 2005.

ROUNDTABLE DISCUSSION:

Pepplitsch reported to Council that Dan's Sanitation is requesting an increase in their fees, due to the recent increase in fuel costs. Administration was directed to submit a Resolution reflecting this increase, at the September 27, 2005 Meeting for Council's consideration.
