### **PUBLIC COMMENT:**

Bob Brogan, assistant scout leader of Boy Scout Troop #88, introduced his troop and explained that the members are working towards a communication badge and had questions for the Council. Council members Miller and Bennett answered questions regarding the proposed smoking ban ordinance and the process the Council completed to get the issue on the election ballot.

PUBLIC HEARING - BURCH: Mayor Cook opened the public hearing regarding a special use permit request by Truman and Terri Burch for a fitness studio to be located at 900 N. Washington. Terri Burch appeared before Council to answer Following discussion, Mayor Cook closed the public hearing with thanks to Mrs. Burch. Moved by Fagot, seconded by Tomasek, to approve the Special Use permit request. Roll Call. Voting "aye" were Bennett, Miller, Tomasek, Fagot, Cook. Motion carried.

# PUBLIC HEARING-WITT:

Mayor Cook opened the public hearing for a special use permit request by Clinton and Deb Witt, owners of Grandma's RV Park, to locate a permanent mobile home for their private use at the campground, located at 3030 Plum Creek Pkwy. Cook expressed concerns regarding conditions of a special use permit currently issued to Witt's that are not meeting city codes. Witt replied that he would like to address that issue at a later date. Cook closed the public hearing. Council took no action and directed Pepplitsch to meet with Witt to address code violations and return to Council at a later date.

### HISTORIC STREET LIGHTS:

Pepplitsch requested Council approval of specifications for the Historic Street Lights Phase II project and requested authorization to advertise for material bids. Following discussion, moved by Miller, seconded by Fagot, to approve the material specifications and authorize administration to advertise for bids pending final NDOR approval. Roll call. Voting "aye" were Bennett, Tomasek, Fagot, Miller, Cook. Motion carried.

INTERLOCAL AGREEMENT: Pepplitsch requested Council approval for participation in an interlocal

agreement with Nebraska Phase II Storm Water Communities. Following discussion, moved by Tomasek, seconded by Bennett, to authorize execution of an interlocal agreement for storm water management programs. Roll call. Voting "aye" were Fagot, Miller,

Bennett, Tomasek, Cook. Motion carried.

**LAND GIFT:** Pepplitsch presented Council with a proposed land gift from Peterson

Oil Company; which lot is located in the 800 block of West Vine Street. Following discussion, Council took no action and directed Pepplitsch to contact Peterson Oil Company with contact information

of private investors interested in the lot.

**FINANCIAL REPORT:** Pepplitsch requested Council acceptance of September 2006 financial

report. Moved by Miller, seconded by Fagot, to accept report. Roll call. Voting "aye" were Tomasek, Bennett, Fagot, Miller, Cook.

Motion carried.

**ROUNDTABLE:** Pepplitsch gave a progress report on the Handicap Ramp Improvement

project, new links on city website regarding ongoing projects, and a preliminary lease request by US Cellular for placement of radio equipment on the water tower located at Hwy 30 and Madison Street.

Cook requested an administrative report to Council on liability issues

regarding the City's recreational property.

**ADJOURNMENT:** There being no further business to come before the Council, Mayor

Cook declared the meeting adjourned.
