Following discussion, moved by Tomasek, seconded by Miller, to approve Pay Request #1. Roll call. Voting "aye" were Bennett, Fagot, Miller, Tomasek, Cook. Motion carried.

**TOWER LEASE:** 

Pepplitsch presented a draft lease agreement to Council with US Cellular for placement of radio equipment on City water tower located at 411 North Madison. Following discussion, moved by Miller, seconded by Fagot, to authorize execution of a lease agreement with US Cellular, pending the completion of required signal interference study. Roll call. Voting "aye" were Bennett, Tomasek, Fagot, Miller, Cook. Motion carried.

**ORDINANCE:** 

Pepplitsch requested Council consideration of an ordinance to extend enforcement of the Property Maintenance Code to subdivisions and special use property which lies in the two mile zoning jurisdiction. An ordinance entitled "AN ORDINANCE TO EXTEND THE ENFORCEMENT JURISDICTION FOR THE INTERNATIONAL PROPERTY MAINTENANCE CODE; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR PUBLICATION IN PAMPHLET FROM AND FOR AN EFFECTIVE DATE." Following discussion, Moved by Fagot, seconded by Bennett, to approve ordinance on first reading. Roll call. Voting "aye" were Miller, Tomasek, Bennett, Fagot, Cook. Motion carried.

**ROUNDTABLE:** 

Bennett voiced disappointment in the failure of the smoking ban ordinance to pass during the General Election. She suggested Council study the smoking issue in more detail.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Cook declared the meeting adjourned.
