SMOKING PROHIBITION:

Council considered approval of Resolution placing an Ordinance prohibiting smoking in public buildings and places of employment on the November 2006 general election ballot. Moved by Cook, seconded by Miller, to amend said resolution to read "forum" instead of "hearing". Roll Call. Voting "aye" were Fagot, Bennett, Tomasek, Miller and Cook. Motion carried.

Said Resolution was read before Council. Moved by Miller, seconded by Bennett to approve Resolution No. 06-19. Roll call. Voting "aye" were Bennett, Miller, and Cook. Voting "nay" were Fagot and Tomasek. Motion carries.

RESOLUTION NO. 06-19

A RESOLUTION OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, AUTHORIZING AND DIRECTING THAT A BALLOT ISSUE BE PLACED ON THE GENERAL ELECTION OF NOVEMBER 7, 2006, FOR CONSIDERATION BY THE ELECTORS OF THIS MUNICIPALITY, TO CONSIDER THE ADOPTION OF AN ORDINANCE TO BAN SMOKING IN PUBLIC PLACES;

WHEREAS, Numerous studies have found that tobacco smoke is a major contributor to indoor air pollution, and that second -hand smoke is a cause of disease in healthy nonsmokers, including heart disease, stroke, respiratory disease, and lung cancer; and

WHEREAS, There is no safe level of exposure to secondhand smoke.

WHEREAS, the Mayor and City Council have held a public forum regarding the adoption of an ordinance banning smoking in public places, and have determined that said issue should be submitted to the electorate.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF LEXINGTON THAT:

- The attached Smoking Ban Ordinance, banning smoking in public places, is hereby proposed for approval of the voters of the City of Lexington, Nebraska at the General Election on November 7, 2006.
- 2. That the County Clerk of Dawson County, Nebraska, is directed to submit to the voters of said City the following proposition:

"Shall the City of Lexington, Nebraska adopt a Smoking Ban Ordinance, as proposed by the Lexington City Council? [] YES (For the Ordinance) [] NO (Against the Ordinance) Passed and approved this 22 nd day of August, 2006. CITY OF LEXINGTON. NEBRASKA BY: Ted Cook, Mayor Attest: Shirley Lewis, Deputy City Clerk

ORDINANCE:

An Ordinance entitled "AN ORDINANCE TO ADOPT SEXUAL PREDATOR RESIDENCY RESTRICTIONS: TO PROHIBIT CERTAIN PERSONS SUBJECT TO THE SEX OFFENDER REGISTRATION ACT AND DEFINED AS SEXUAL PREDATORS FROM RESIDING IN CERTAIN AREAS WITHIN THE CITY OF LEXINGTON; TO ESTABLISH PENALTIES FOR A VIOLATION; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS; AND TO PROVIDE AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read before council. Moved by Fagot, seconded by Tomasek, to suspend the rules requiring the reading of said ordinance on three separate occasions. Roll call. Voting "aye" were Bennett, Miller, Tomasek, Fagot, Cook. Motion carried.

Said Ordinance was read by title. Moved by Fagot, seconded by Bennett to approve Ordinance No. 2216 on Final Reading. Roll call. Voting "aye" were Tomasek, Miller, Bennett, Fagot, Cook. Motion carried.

ORDINANCE:

Pepplitsch requested Council's consideration of an ordinance providing for the licensing and regulation of street vendors. Following discussion, the council directed city administration to develop fee schedule and bring back to Council at later date.

PROJECT PLANS:

Dana Daniels presented plans and specifications for the Handicap Ramp Improvement Project. Moved by Miller, seconded by Fagot to accept plans and specifications and authorize advertisement for bids contingent on approval from NDOR. Roll Call. Voting "aye" were Tomasek, Bennett, Fagot, Miller, Cook. Motion carried.

FINANCIAL REPORT:

Pepplitsch requested Council's acceptance of the Financial Report for July 2006. Following discussion, moved by Miller, seconded by Tomasek, to accept the report. Roll call. Voting "aye" were Fagot, Bennett, Tomasek, Miller, Cook. Motion carried.

ROUNDTABLE DISCUSSION: Pepplitsch requested input from Council regarding discontinuing leaf collection service currently done by the City. Council directed Administration to issue a news release to inform citizens of the discontinuation of leaf collection service.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Cook declared the meeting adjourned.
