

# **Stormwater Quality**

#### Why does stormwater quality matter?

The storm drainage system is designed to collect stormwater — rain and snowmelt — and release it directly into the Colorado River. Pollutants, such as fertilizers, pesticides, oils and other sediments are transported in stormwater as rain and snowmelt travel across lawns, roads, parking lots and other surfaces. This polluted stormwater then enters the Colorado River without filtration or treatment. Contaminants that enter the stormwater system degrade the quality of our drinking water and pollute our fish and wildlife habitats.

#### How can you help?

As good stewards of the Colorado River, we must take extra precautions to ensure that stormwater runoff does not jeopardize the quality of our natural water source. Implementing Best Management Practices (BMPs) and reviewing waste management systems will help ensure a safe work environment and provide a cleaner water source for years to come.

# **BMP - Stormwater Quality for Restaurants**

Thank you for taking the time to review and apply Best Management Practices (BMP) for stormwater quality in our community. Through education and steadfast improvements, we can protect our rivers and preserve our local fish and wildlife.

#### **Good Housekeeping Practices**

- Avoid spilling onto floors or other surfaces through good housekeeping.
- Clean up spills immediately to minimize safety hazards and prevent spills from reaching a storm drain inlet.
- Use absorbent materials to clean small spills rather than hosing down the area. Remove the absorbent materials promptly and dispose of properly.

#### Cleaning

- Keep outside areas (dumpsters, parking lots, etc.) free of trash and debris, and regularly clean them to prevent pollutant buildup.
- Control litter by sweeping and picking up trash on a regular basis.
- Sweep up outside areas rather than washing them down.
- Do not dump mop water or wash floor mats or kitchen equipment outside. Pour mop water and wash water into the mop sink or floor drains. Take floor mats to a local car wash for cleaning.
- Whenever possible, purchase water-based cleaning products. Look for products labeled "nontoxic," "non-petroleum based," "ammonia-free," "phosphate-free," "dye and perfume-free," or "readily biodegradable."

#### **Oil and Grease**

- Regularly inspect and clean out grease traps/interceptors.
- Always use proper oil and grease recycling receptacles. Never dump oil and grease wastes into storm drains or onto parking lots.
- Use care to avoid spills when taking used oil to the grease receptacle.

## StormWater Pollution . . . What You Should Know

Riverside County has two drainage systems - sanitary sewers and storm drains. The storm drain system is designed to help prevent flooding by carrying excess rainwater away from streets. Since the storm drain system does not provide for water treatment, it also serves the *unintended* function of transporting pollutants directly to our waterways.

Unlike sanitary sewers, storm drains are not connected to a treatment plant - they flow directly to our local streams, rivers and lakes.

Waste or washwater generated by the food service industry often contains materials such as food wastes, oil, grease, detergents, and degreasers. These materials can degrade local waters when allowed to flow into a storm drain system.

Stormwater pollution causes as much as 60% of our water pollution problem. It jeopardizes the quality of our waterways and poses a threat to groundwater resources if pollutants percolate through soil.



## The Cities and County of Riverside StormWater/CleanWater Protection Program

Since preventing pollution is much easier, and less costly, than cleaning up "after the fact," the Cities and County of Riverside StormWater/CleanWater Protection Program informs residents and businesses on pollution prevention activities such as the Best Management Practices (BMPs) described in this pamphlet.

The Cities and County of Riverside have adopted ordinances for stormwater management and discharge control. In accordance with state and federal law, these local stormwater ordinances **prohibit** the discharge of wastes into the storm drain system or local surface waters. This includes discharges from the food service industry containing food wastes, oil, grease, detergents, and degreasers.

**PLEASE NOTE:** A common stormwater pollution problem associated with the food service industry is the discharge of washwater into alleys and gutters, and the hosing down of outdoor areas. Often, these activities flush pollutants into the storm drain system. The discharges of pollutants is *strictly prohibited* by local ordinances and state and federal regulations.

# A Menu of Activities . . . to Keep Our Water Clean

## Cleanin' It Right . . .

Pour mop and wash water into the mop sink or down floor drains . . . not into gutters,

alleys, parking lots or a storm drain. Wash greasy equipment only in designated wash areas which are properly connected to

the sewer system with an appropriate oil/water separator. Also, avoid washing kitchen mats, garbage containers, and other items in areas where wastewater is likely to flow into a storm drain.

## Watch Out For Spills ...

Use dry methods for spill cleanup. Don't hose



down outside spills. Use rags or absorbents such as cat litter and then dispose of in the garbage, or handle as hazardous waste as appropriate. If necessary, mop the area with a minimum amount of water.

# Proper Storage and Disposal . . .

General cleaners, floor cleaners, solvents, and detergents often contain toxic substances. Read labels carefully and store and dispose of these products properly.

REMEMBER: Don't throw toxic waste into the trash or into a storm drain. To report toxic spill call 911. For information on hazardous waste pick-up call (909) 358-5055.

## Grease and Oil . . .

Handle and dispose of grease properly. Save used cooking grease and oil for recycling in tallow bins or sealed containers. Never pour grease into a sink, floor drain, dumpster or storm drain.

## How 'Bout That Dumpster . . .

Keep dumpster and loading dock areas clean. Control litter by sweeping - don't hose down

the area. Replace leaky dumpsters and keep lids closed to keep out rainwater.

# Use Water-Friendly Products . . .

Whenever possible, purchase water-based cleaning products. Look for products labeled "non-toxic," "non-petroleum based," "ammonia-free," "phosphate-free," and "perfume-free,"

#### or "readily biodegradable."

## Outdoor/Sidewalk Areas . . .

Sweep up food particles, cigarette butts, and trash from outdoor dining areas before

rinsing or steam cleaning. Don't use toxic bleaches or detergents when you pressure wash outdoor dining areas, entrances or surrounding sidewalk areas.

**You may be** already implementing many of the BMPs prescribed in this brochure. However, if you discover any potential problem areas, please consider using one or more of the recommended BMPS.

**Also,** please note that the Riverside County Environmental Health Department will monitor potential sources of stormwater pollution activities during regularly scheduled inspections of food service facilities. If Health Department staff observe activities which may be contributing to stormwater pollution, suggestions will be provided and/or use of prescribed BMPS listed in this brochure will be offered.


The Nebraska H<sub>2</sub>0 program has been established in order to change the statistics and protect our waterways before any more damage is done. But we need your help.

According to a recent government survey, 40 percent of U.S. waterbodies were still impaired by pollution, failing to meet government standards. It's a problem we contribute to - most of the time unknowingly - when we let harmful

pollutants run into our storm drains and enter our waterways.







### About us Our mission. Our efforts. Our request.

It's a pretty common belief that the water in our storm drains is filtered or treated before it makes its way into our rivers and lakes.

The truth is, it's not.

When we dump harsh chemicals on our lawns and dispose of toxic substances via storm drains, harmful pollutants enter our waterways, killing fish, destroying wildlife habitats, decreasing aesthetic value and contaminating the water we boat in, swim in – and drink. It's a risk to our environment. . . and a risk to our health.

Using grant funding provided by the State of Nebraska and administered by the Nebraska Department of Environmental Quality, the Nebraska Stormwater Cooperative is working to raise awareness and offer alternatives to storm drain dumping through our Nebraska  $H_20$  program. Almost half of U.S. waterbodies fail to meet water quality standards. It's our goal to change this – to protect our waters and improve the health of our citizens and wildlife.

(The Nebraska Stormwater Cooperative consists of Grand Island, Beatrice, Columbus, Fremont, Hastings, Kearney, Lexington, Norfolk, North Platte and Scottsbluff.)





## What you can do to help

Easy tips for keeping our waters clean.

### Litter disposal

Dispose of litter by throwing it in a trashcan or recycling it. In addition, do your part by disposing of litter you find in the street or on the sidewalk.

### Washing your car

You can either take your car to a selfservice car wash, which is designed with special drains for proper disposal, or wash your car on your lawn. The dirt below will act as a filter for the soap.

#### Pet waste

It's best to dispose of pet waste in the trash or, better yet, flush it down the toilet. This water will be properly treated.

### Household chemicals

Cleaning products and other household chemicals should never be dumped outside, down the sink – or down a storm drain. Visit www.NebraskaH2O.org and click on our Tips section to find out the location of a facility that will dispose of them properly.

## Fertilizer and pesticides

You'll need to take leftover substances to a designated waste control area. Visit www.NebraskaH2O.org to find out the location nearest you.
