AN ORDINANCE TO AMEND SECTION 16-41 OF THE LEXINGTON CITY CODE; TO PROVIDE FOR SPEED LIMITS ON AIRPORT ROAD; TO REPEAL ORIGINAL SECTION 16-41, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA AS FOLLOWS:

Section 1. That Section 16-41 of the Lexington City Code is hereby amended to read as follows:

Sec. 16-41 Same--Other Specific Speed Limits.

(a) The speed limit shall be thirty miles per hour on the following streets or parts of streets:

Plum Creek Parkway and Jackson Street, Maple to Fifth Street

Fifth Street, Grant to Jefferson

Grant Street, Fifth Street to Pacific Avenue

Jefferson Street, Pacific Avenue to Fifth Street

(b) The speed limit shall be thirty-five miles per hour on the following streets or parts of streets:

Adams Street, from Drainage District No. 1 drainage ditch to Oak Street, and U.S. Highway 30 to the City Limits north of 20th Street

Pacific Avenue, 700 feet East of Monroe Street to 600 feet West of Adams Street

Taft Street, Pacific Avenue to 13th Street

West Walnut Street, Adams Street West to the City Limits

East Walnut Street, Plum Creek Parkway East to the City Limits

Cattlemen Drive, Adams Street to Plum Creek Parkway

East Industry Drive, Walnut Street to Prospect Road

Prospect Road, Plum Creek Parkway West to the City Limits

Airport Road, Highway 30 North to the City Limits
