





To Whom It May Concern,

Your property described as, Lot 1, Block 2, Westminster Woods Second, Lexington, NE is in violation of the Zoning Ordinance of the City of Lexington. The property was is located in an A-1 Agriculture District. Your use of the structures as apartment living is a violation of the Lexington Zoning Ordinance. You shall cease the use immediately.

If the violation is not corrected you may be subject to penalties, including a fine of up to \$500 a day, with each day the violation continues being a separate offense. Further, the City of Lexington may forward the matter to the City Attorney who may commence further legal action against you.
