The City of Lexington is requesting to extend the contract end date for 15-HO-33075 from October 1, 2018, to October 1, 2019. Due to previous staffing changes and number of homeowner applications received, the City does not have sufficient time to complete all housing activities outlined in the CDBG executed contract. Providing a one-year extension will allow the City to provide adequate housing inspections, bidding of projects, and quality construction work for homeowners. We do not anticipate this request to be a repetitive issue.

The City Council approved this request on September 11, 2018, at their regular Council meeting. A copy of the meeting minutes is attached, showing Council approval of the extension. I also certify that the City continues to agree to fund whatever matching funds remain and are required.
