**PUBLIC HEARING:** 

Mayor Fagot opened the public hearing for the Council to consider a "D" Liquor License Application by Hi Times Liquor Mart LLC dba Hi Times Liquor Mart #2. Linda Shivelbein noted that the company is changing from a corporation to a limited liability company, which requires a change in their liquor license. Council member Tomasek noted that the local business was recently cited for selling to minors. Shivelbein reported that the employee involved was immediately terminated and reiterated that they have a zero tolerance policy. The public hearing was closed. Moved by Miller, seconded by Tomasek, to recommend approval to the Liquor Control Commission of the application for a "D" Liquor License application by Hi Times Liquor Mart LLC dba Hi Times Liquor Mart #2. Roll call. Voting "aye" were Tomasek, Miller, Fagot. Motion carried.

CDBG APPLICATION: ED RE-USE FUND

Mayor Fagot opened the public hearing to consider an application to the CDBG ED Re-use fund by the City of Lexington for \$600,000. Pepplitsch explained that the requested funds would be used to purchase of the former Wal-Mart building, and a plan to repay the loan funds. The public hearing was closed. Following discussion, moved by Miller, seconded by Tomasek, to approve the application to the CDBG Economic Development Re-Use fund for \$600,000.00. Roll call. Voting "aye" were Tomasek, Miller, Fagot. Motion carried.

CDBG APPLICATION: HOUSING RE-USE FUND

Mayor Fagot opened the public hearing to consider an application to the CDBG Housing Reuse Fund by the City of Lexington in the amount of \$50,000. Pepplitsch explained that the funds would be used to help establish a speculative house risk sharing program, to be administered by DAD on behalf of the City of Lexington. The funds would be available to home builders to provide short term interest assistance on spec home construction. Pepplitsch reviewed the guidelines for the program and noted that the cities of Cozad and Gothenburg will also be participating with similar investment. The public hearing was closed. Following discussion, moved by Tomasek, seconded by Miller, to approve the application to the CDBG Housing Reuse by the City of Lexington in the amount of \$50,000.00. Roll call. Voting "aye" were Miller, Tomasek, Fagot. Motion carried.

MONROE ST IMP:

Deb Jensen, DAD, requested approval of special condition documentation related to CDBG 07-PW-015, Monroe Street Improvements. Following discussion of the special conditions, moved by Miller, seconded by Tomasek, to approve the documentation and authorize the Mayor and City Manager to execute the documents related to CDBG 07-PW-015, Monroe

Street Improvements. Roll call. Voting "aye" were Tomasek, Miller, Fagot. Motion carried.

**GRANT SERVICES:** 

Pepplitsch requested Council approval to procure grant administrative services for CDBG 07-PW-015, Monroe Street Improvements. He explained that one proposal was received from DAD, in the amount of \$11,700. Following discussion, moved by Miller, seconded by Tomasek, to authorize the City Manager to procure grant administrative services from DAD for the project. Roll call. Voting "aye" were Tomasek, Miller, Fagot. Motion carried.

**PAY REQUEST:** 

Dana Daniels requested Council approval of Pay Request #2 from Paulsen, Inc. in the amount of \$26,892.00 for the CED Addition Paving Improvements project. Following an update of the project, moved by Tomasek, seconded by Miller, to approve the pay request in the amount of \$26,892.00. Roll call. Voting "aye" were Miller, Tomasek, Fagot. Motion carried.

**RESOLUTION:** 

Pepplitsch presented a request from Dan's Sanitation to amend the solid waste collection fuel surcharge. Following discussion, Resolution 08-12 was read. Moved by Tomasek, seconded by Miller, to approve Resolution 08-12. Roll call. Voting "aye" were Miller, Tomasek, Fagot. Motion carried.

## **RESOLUTION 08-12**

WHEREAS, fuel fees have increased due to uncertain market conditions, thereby increasing the cost of operating the trash collection service for The City of Lexington.

BE IT THEREFORE RESOLVED, that effective June 1, 2008, a fuel cost adjustment fee will be charged to residential solid waste collection customers within the City of Lexington and shall be at the rate of \$1.05 per month.

BE IT FURTHER RESOLVED, that the fuel cost adjustment shall be monitored by the Lexington City Manager, and eliminated upon determination that the charge is no longer appropriate.
