STAT. §76-2,112 (2003), on January 27, 2009, the City of Lexington forwarded the easement request to the City of Lexington Planning and Zoning Commission for their review and recommendations regarding the conformity of the proposed acquisition to comprehensive planning for the area; and

WHEREAS, also pursuant to NEB. REV. STAT. §76-2,112 (2003) on February 4, 2009, the City of Lexington Planning and Zoning Commission recommended approval of the easement at their regularly scheduled meeting; and

NOW, BE IT RESOLVED by the City of Lexington that the designated conservation easement on the real estate legally described hereinabove and more specifically set forth in the Deed of Conservation Easement attached hereto as Exhibit "A" and incorporated herein by this reference, should be, and hereby is, approved.

Pepplitsch encouraged the members of the council who are to meet with the School Building and Grounds Committee to schedule a meeting as soon as possible. He also gave a brief update of the Legend Oaks housing project.

Burnside noted that a number of Planning Commission members are planning to attend the Nebraska Planning and Zoning Association conference in Grand Island later this month.

Fagot stated that he had been approached by two citizens requesting the council revisit the carry concealed weapons ordinance. There was no

interest from the other council members in doing this at this time. He also gave an update on the board reorganization of the LASWA. He noted that he has also been reappointed by the Governor of Nebraska to serve on the Executive Board of the Workforce Development of Greater Nebraska. He served on the board previously from 1998-2004.

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
