A Regular Meeting of the Lexington City Council was held Tuesday, July 28, 2009, at the Lexington Municipal Building, located at 406 E. 7<sup>th</sup> Street, Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, Steve Tomasek, Joni Bennett, Linda Miller and John Salem. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, Finance Director Barb Mills and Deputy City Clerk Pamela Berke. City Attorney Will Weinhold was absent. The press was represented by the Kearney Hub and the Lexington Clipper-Herald. Also in attendance were Dana Daniels, Deb Jensen, Irving Hiatt, and Gordon and Joyce Rimpley.

**CALL TO ORDER:** 

The meeting was called to order by Mayor Fagot. Fagot informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington Municipal Building, located at 406 E. 7<sup>th</sup> Street, Lexington, Nebraska.

## **ORDINANCE:**

An ordinance entitled "AN ORDINANCE TO AMEND SECTION 16-45 OF THE LEXINGTON CITY CODE; TO RESTRICT PARKING ALONG SEGMENTS OF A PEDESTRIAN TRAIL AND ALONG FRONTIER STREET; TO REPEAL ORIGINAL SECTION 16-45 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented for second reading. Pepplitsch reported that he had not received any comments on the proposed ordinance. Joyce Rimpley expressed her support of the ordinance. Following discussion, moved by Salem, seconded by Miller, to suspend the rules regarding the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Salem, Fagot. Motion carried.

Ordinance No. 2265 was presented on final reading. Moved by Salem, seconded by Miller, to approve Ordinance No. 2265 on final reading. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Salem, Fagot. Motion carried.

**SPECIAL USE PERMIT:** 

Mayor Fagot opened a public hearing to consider a Special Use Permit application by Irving Hiatt for Westminster Woods, Lot 2. Irving Hiatt gave a review of the intended use for the property which would include a meeting/reception hall and dance studio. Pepplitsch noted that a single family dwelling is not a permitted use in an M-1 zone as included in the application. Discussion regarding the special use permit being tied to the building and property was held. Joyce Rimpley, a neighbor, commented on the progress of the cleanup of the area done by the Hiatts. She did question if there is intent to apply for a liquor license to go with the property. Mr. Hiatt stated that there is no intent to apply for a liquor license. The public hearing was closed. Following discussion, moved by Miller, seconded by Tomasek, to approve the application contingent upon a special use permit agreement to be approved by applicant and city council. Roll call. Voting "aye" were Bennett, Salem, Tomasek, Miller, Fagot. Motion carried.

Rimpley requested that any future development of the Westminster Woods area include signage designating county roads and traffic controls.

**PUBLIC HEARING:** 

Mayor Fagot opened a public hearing to discuss a status update on current CDBG programs which include Monroe Street Paving Improvements and Owner Occupied Rehabilitation Program. Deb Jensen, DAD, gave an update on each project as required in the grant awards. She reported that the concrete work has been completed on the Monroe Street Improvement project and the asphalt overlay work will begin in September. The grant has a completion deadline of March 2010. She reported that this is the third round of grant funding for the OOR program; to date 40 houses have been rehabilitated in Lexington. This grant is scheduled to close in January 2010. With no further public comment, the public hearing was closed.

**BID AWARD:** 

Dana Daniels, Miller & Associates, presented the bid tabulation for the Legend Oaks Infrastructure Improvements project. He noted that Paulsen Inc. was the low bidder at \$115,533, and recommended awarding the contract. Following discussion, moved by Salem, seconded by Bennett, to accept the bids as presented and award a contract to Paulsen Inc. Roll call. Voting "aye" were Tomasek, Miller, Bennett, Salem, Fagot. Motion carried.

**BID AWARD:** 

Daniels presented the bid tabulation for the Optimist Soccer Field Stadium Improvements project. He noted that Paulsen Inc was the low bidder on this project at \$44,297, and recommended awarding a contract. Following discussion, moved by Miller, seconded by Salem, to accept the bids as presented and award a contract to Paulsen Inc. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Miller, Fagot. Motion carried.

OPPORTUNITY CENTER PHASE I:

Pepplitsch requested Council approval of plans and specifications, as well as authorization to solicit bids for the Opportunity Center Phase I Improvements project. Following discussion, moved by Miller, seconded by Tomasek, to approve the plans and specifications and authorized the city manager to solicit bids for the Opportunity Center Phase 1 Improvements

project. Roll call. Voting "aye" were Bennett, Salem, Tomasek, Miller, Fagot. Motion carried.

#### AIRPORT BUDGET REQUEST:

Pepplitsch requested approval of a resolution allocating levy authority to the Lexington Airport Authority for Fiscal Year 2010, which is an annual request. The resolution was read, following discussion, moved by Salem, seconded by Bennett, to approve Resolution No. 09-17. Roll call. Voting "aye" were Tomasek, Miller, Bennett, Salem, Fagot. Motion carried.

#### **RESOLUTION NO. 09-17**

WHEREAS, the Lexington Airport Authority has requested an allocation of a part of the City of Lexington property tax levy for budget purposes.

BE IT RESOLVED, by the Mayor and Council of the City of Lexington, Nebraska, that \$120,000.00 of the City of Lexington Property Tax Levy Authority is hereby allocated to the Lexington Airport Authority for the fiscal year 2009-2010.
