Pepplitsch reviewed the history and issues of the Westminster Woods Subdivision and highlighted areas of interest in a subdivision agreement. He noted that the agreement stipulates that prior to any use or development on four lots zoned M-1, a public hearing was needed for Council approval through the special use process. Following discussion, moved by Miller, seconded by Tomasek, to approve the subdivision agreement as presented. Roll call. Voting "aye" were Bennett, Tomasek, Miller, Fagot. Motion carried.

ORDINANCE:

An ordinance entitled "AN ORDINANCE TO REZONE LOTS 1, 2, 3, & 4, WESTMINSTER WOODS SUBDIVISION, FROM A-1 AGRICULTURAL DISTRICT TO M-1 LIGHT INDUSTRIAL DISTRICT; TO REZONE LOTS 5, 6, & 7 FROM A-1 AGRICULTURAL DISTRICT TO R-2 RESIDENTIAL DISTRICT; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was read on second reading. Moved by Tomasek, seconded by Bennett, to suspend the rules regarding reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Fagot. Motion carried.

Ordinance No. 2259 was read by title. Moved by Bennett, seconded by Tomasek, to approve Ordinance No. 2259 on final reading. Roll call. Voting "aye" were Miller, Tomasek, Bennett, Fagot. Motion carried.

PUBLIC HEARING:

Mayor Fagot opened the public hearing to take public comment on the proposed Lexington Economic Development Program 2010-2020. Pepplitsch gave an overview of the program. Toby Owens, CED vice-president, provided CED support for the program as an indispensable funding mechanism for the community. Being no further comments, the public hearing was closed.

RESOLUTION:

Resolution No. 09-06 was read by title. Pepplitsch gave an overview of a special election process related to the economic development program. Moved by Tomasek, seconded by Bennett, to approve Resolution No. 09-06 as presented. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Fagot. Motion carried.

RESOLUTION NO. 09-06

A RESOLUTION OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, AUTHORIZING AND DIRECTING THAT A BALLOT ISSUE BE PLACED ON A SPECIAL ELECTION OF MAY 12, 2009 FOR CONSIDERATION BY THE ELECTORS OF THIS MUNICIPALITY TO CONSIDER THE ADOPTION OF THE LEXINGTON ECONOMIC DEVELOPMENT PROGRAM AS PRESENTED PER THE LOCAL OPTION MUNICIPAL ECONOMIC DEVELOPMENT ACT.

WHEREAS, the growth of the economy of the City of Lexington is critical to the city's ability to grow and prosper in the future; and

WHEREAS, it is vital for Lexington to develop techniques that will encourage this necessary economic growth; and

WHEREAS, the Nebraska Legislature adopted the Local Option Municipal Economic Development Act giving cities the opportunity to use locally derived municipal revenues for economic and industrial development purposes; and

WHEREAS, this plan by state statue must include specific components, including the statement of a general economic development strategy; a statement of purpose describing general intent and goals; a description of the types of businesses and activities that will be eligible for assistance under the program; a description of the amount of funds to be collected from local sources; a statement of the length of time that the program will be in existence; a preliminary budget for the program; an application process for financial assistance to businesses; an administrative system for the program; a process to assure that laws and regulations are being met by municipalities and businesses; a process by which industrial lands might be identified for purchase; and a description of various detailed aspects of an economic development loan program; and

WHEREAS, to satisfy these requirements, the City of Lexington has caused the completion of and Economic Development Plan that meets these statutory requirements and presents a program that is appropriate to the needs of the community; and

WHEREAS, the Mayor and City Council desire to proceed with a local option municipal economic development program based upon this plan;

WHEREAS, the Mayor and City Council have held a public hearing regarding the adoption of an Economic Development Program using funds from existing local option sales tax;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF LEXINGTON THAT:

- 1. The attached Economic Development Program is adopted as the official Economic Development Program for the City of Lexington, pursuant to the requirements of Section 11 of the Local Option Municipal Economic Development Act of 1991; and
- 2. That this Plan shall be maintained on file with the City Clerk, who shall make it available for the public to review during regular business hours; and
- 3. It is the intent of the Mayor and City Council to place approval of a local option economic development program to implement this Plan before the voters of the City of Lexington on May 12, 2009.
- 4. That the County Clerk of Dawson County, Nebraska, is directed to submit to the voters of said City the following proposition:

Issue #1

"Shall the City of Lexington establish an Economic Development Program as described in its adopted Economic Development Plan by appropriating annually from local sources of revenue \$167,500.00 for 10 years?"

Terms and Conditions of the Program.

- A. The goals of the program shall be to create well-paying jobs for the citizens of Lexington; to expand labor markets of Lexington and Dawson County; to attract new capital investment to the community to broaden the tax base; to retain existing jobs and make existing businesses more competitive and profitable; and provide economic diversification to ensure economic stability and vitality for the City of Lexington and surrounding areas.
- B. Funds for the program may be used for the following purposes: public works improvements, job credits, purchase of real estate, technical assistance, recruitment expenses, loans or grants for fixed assets or working capital, location expenses, loan guarantees, job training assistance, building rehabilitation, small business development, tourism, contracting for administration of program, issuance of bonds, and as otherwise established by Nebraska law.
- C. The Program shall commence May 1, 2010, and end April 30, 2020, a ten (10) year period.
- D. Collection of funds shall begin May 1, 2010 and end April 30, 2020.

- E. The source from which funds are to be collected shall be 1/5 of the existing 1% City Local Option Sales Tax.
- F. The total amount to be collected from the local sources of revenue for the Economic Development Program will be \$1,675,000.00 over a 10-year period, or \$167,500.00 annually.

A RESOLUTION OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, AUTHORIZING AND DIRECTING THAT A BALLOT ISSUE BE PLACED ON A SPECIAL ELECTION ON MAY 12, 2009 FOR CONSIDERATION BY THE ELECTORS OF THIS MUNICIPALITY TO CONSIDER THE USE OF EXISTING SALES TAX REVENUE TO FUND THE LEXINGTON ECONOMIC DEVELOPMENT PROGRAM AS PRESENTED PER THE LOCAL OPTION MUNICIPAL ECONOMIC DEVELOPMENT ACT.

WHEREAS, the Lexington City Council has approved the Lexington Economic Development Program Plan as authorized by the Local Option Municipal Economic Development Act; and

WHEREAS, said Local Option Municipal Economic Development Act authorizes the municipality to utilize city sales tax for the funding of said economic development program upon approval of the electors of the municipality.

BE IT THEREFORE RESOLVED BY THE MAYOR AND CITY COUNCIL OF LEXINGTON, DAWSON COUNTY, NEBRASKA:

- There shall be submitted to the electors of the City of Lexington, at a special election to be held May 12, 2009, the issue of whether the City of Lexington should adopt an ordinance authorizing use of 1/5 of the existing 1% Local Option Sales Tax to fund the Lexington Economic Development Program.
- 2. That the County Clerk of Dawson County, Nebraska, is directed to submit to the voters of said City the following proposition:

Issue #2

"Shall the Mayor and the City Council of the City of Lexington, Nebraska, be authorized to use 1/5 of the existing 1% Local Option Sales Tax to fund the Lexington Economic Development Program to create jobs and ensure the

economic stability and vitality of Lexington	ı, Nebraska for a ten year period

PUBLIC HEARING:

Mayor Fagot opened the public hearing for rezoning Blk 3, Parkview Addition from R-3 Multi-family Residential to RP-3 Planned Residential. Pepplitsch presented the development plan of the Legend Oaks Housing Project and explained the need for the planned unit zoning designation. Corey Cetak, a resident on Sunset Drive, voiced his concerns regarding traffic safety at the proposed 18th and Adams Streets intersection. The public hearing was closed.

Moved by Tomasek, seconded by Bennett, to suspend the rules requiring the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Fagot. Motion carried.

Ordinance No. 2260 was read by title. Moved by Miller, seconded by Tomasek, to approve Ordinance No. 2260 on final reading. Roll call. Voting "aye" were Bennett, Tomasek, Miller, Fagot. Motion carried.

ELECTRIC PROJECT:

Pepplitsch requested Council approval of an electric system capital improvement project, the installation of substation transformer in the East Walnut substation. Following discussion, moved by Miller, seconded by Bennett, to approve Electric Project Order No. 4662614 as presented. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Fagot. Motion carried.

PARK WORK PLAN:

Burnside gave an overview of the Park Improvement Committee's proposed 2009 park work plan. These items included additional skate park equipment and playground equipment in Arbor Park. Pepplitsch also gave an update on meetings with the School's Building & Grounds committee related to the soccer field project. Following discussion, moved by Miller, seconded by Bennett, to approve the 2009 Park Improvement Plan as presented. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Fagot. Motion carried.

FORECLOSED PROPERTIES: Pepplitsch reported that two properties with city assessments levied against them are scheduled for sheriff's sale on March 25, 2009. Following discussion, moved by Tomasek, seconded by Bennett, to authorize the City Manager to protect the city's interest in these

properties. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Fagot. Motion carried.

SALE OF PROPERTY:

Following discussion regarding the sale of the property to the CED, moved by Tomasek, seconded by Miller, to suspend the rules regarding reading an ordinance on three separate occasions. Roll call. Voting "aye" were Bennett, Miller, Tomasek, Fagot. Motion carried.

Ordinance No. 2261 was read by title. Moved by Miller, seconded by Tomasek, to approve Ordinance No. 2261 on final reading. Roll call. Voting "aye" were Bennett, Tomasek, Miller, Fagot. Motion carried.

ROUNDTABLE:

Pepplitsch reminded Council members about expense reports from the League conference and a reception honoring Ivan Riege for 40 years of service and his retirement. He also noted that he will be taking some personal time in the next few weeks. He reported on some upcoming agenda items.

Burnside announced that Pam Berke would be at Clerk School during the week of March 16-20 and that one of the police officers has been called to active duty in the military.

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
