STAT. §76-2,112 (2009), on November 9, 2010, the City of Lexington forwarded the easement request to the City of Lexington Planning and Zoning Commission for their review and recommendations regarding the conformity of the proposed acquisition to comprehensive planning for the area; and

WHEREAS, also pursuant to NEB. REV. STAT. §76-2,112 (2009) on December 1, 2010, the City of Lexington Planning and Zoning Commission recommended approval of the easement at their regularly scheduled meeting; and

NOW, BE IT RESOLVED by the City of Lexington that the designated conservation easement on the real estate legally described hereinabove and more specifically set forth in the Deed of Conservation Easement attached hereto as Exhibit "A" and incorporated herein by this reference, should be, and hereby is, approved.

project. Following discussion, moved by Miller, seconded by Tomasek, to

- **ROUNDTABLE:** Pepplitsch provided an update on the police chief search, anticipating the position to be filled by March 2011.

Weinhold reported that police officers have been issuing warning citations for parking restrictions in the downtown area to educate the public on the newly adopted restrictions. Miller reported that she will be unable to attend the December 28 and January 11 council meetings.

Fagot requested potential dates for a planning session in January 2011.
