ORDINANCE:

PUBLIC HEARING:

Mayor Fagot opened the public hearing to consider an application to Nebraska Department of Economic Development for a Nebraska Affordable Housing Program grant. Pepplitsch explained that the application as previously approved was amended for the project. Following a review of the application and discussion, the public hearing was closed.

Resolution No. 2010-13 was presented for consideration. Moved by Miller, seconded by Salem, to approve Resolution No. 2010-13 as presented. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Miller, Fagot. Motion carried.

RESOLUTION # 2010-13

A RESOLUTION TO AUTHORIZE THE COUNCIL PRESIDENT AND CITY MANAGER OF THE CITY OF LEXINGTON TO SIGN AN APPLICATION FOR NEBRASKA AFFORDABLE HOUSING PROGRAM FUNDS

Whereas, the City of Lexington, Nebraska, is an eligible unit of a general local government authorized to file an application under the Housing and Community Development Act of 1974 as Amended for Small Cities Community Development Block Grant Program, and, Cranston-Gonzalez National Affordable Housing Act of 1990 (HOME Program) funds distributed by the Department of Economic Development through the Nebraska Affordable Housing Program.

Whereas, the City of Lexington, Nebraska, has obtained its citizens' comments on community development and housing needs; and has conducted a public hearing upon the proposed application and received favorable public comment respecting the application which for an amount of \$500,000 for the New Neighborhood Initiative; and,

NOW, THEREFORE, BE IT RESOLVED BY The Lexington City Council of the City of Lexington, that Council President, John Fagot and City Manager, Joe Pepplitsch, be authorized and directed to proceed with the formulation of any and all contracts, documents or other memoranda between the City of Lexington and the Nebraska Department of Economic Development so as to effect acceptance of the grant application.

LIQUOR LICENSE APP:

Mayor Fagot opened a public hearing to consider a Class "D" Liquor License Application by Karina Lupercio dba "K" Liquors, 200 East 4th, Lexington. Derek Mitchell stated that she is purchasing the existing assets of the closed facility and will be leasing the building. She will be completing training required by the Liquor Control Commission. The public hearing was closed. Following discussion, moved by Salem, seconded by Tomasek, to recommend approval of the Class "D" Liquor License application by Karina Lupercio dba "K" Liquors to the Nebraska Liquor Control Commission as presented. Roll call. Voting "aye" were Bennett, Miller, Tomasek, Salem, Fagot. Motion carried.

PUBLIC HEARING:

Mayor Fagot opened a public hearing to consider a report from the Citizens Advisory Review Committee. Pepplitsch reviewed the activity in the Lexington Economic Development Program. There were no committee recommendations at this time. The public hearing was closed. Moved by Miller, seconded by Tomasek, to accept the Citizens Advisory Review Committee report as presented. Roll call. Voting "aye" were Bennett, Salem, Tomasek, Miller, Fagot. Motion carried.

WEST CENTRAL AREA AGENCY ON AGING:

Pepplitsch reviewed an operating contract with WCAAA for the Grand Generation Center Meals Program for FY 2011. Following a review of the program and reimbursement rates, moved by Tomasek, seconded by Salem, to approve the contract as presented and authorizes the mayor to execute the required documents. Roll call. Voting "aye" were Bennett, Miller, Salem, Tomasek, Fagot. Motion carried.

DISTRICT 09-02:

Daniels presented the bid tabulation for the Paving Improvement District 09-02 project, noting that the low bid was over the engineer's estimate by approximately 29%, mainly due to asphalt prices and the modification of storm water facilities within a specific area of the project. Pepplitsch and Daniels outlined possible options. Following discussion, moved by Miller, seconded by Salem, to authorize the city manager to negotiate and execute a contract with the low bidder, Western Engineering, to within approximately 15% of the engineer's estimate. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Miller, Fagot. Motion carried.

PAY REQUEST:

Pepplitsch presented Pay Request #8 for the Dawson County Opportunity Center Phase 1 project from Paulsen Inc. in the amount of \$53,402.16. Following a project update, moved by Salem, seconded by Bennett, to approve the pay request as presented. Roll call. Voting "aye" were Miller, Tomasek, Bennett, Salem, Fagot. Motion carried.

PAY REQUEST:

Pepplitsch presented Pay Request #1 for the Dawson County Opportunity Center Phase 2 project from Simon Contractors in the amount of \$7,830.00. Following a project update, moved by Bennett, seconded by Miller, to approve

the pay request as presented. Roll call. Voting "aye" were Tomasek, Salem, Miller, Bennett, Fagot. Motion carried.

PAY REQUEST:

Pepplitsch presented Pay Requests #1 and #2 for the Soccer Field Building project from Paulsen Inc. in the amounts of \$67,248.00 and \$25,893.00 respectively, for a total of \$93,141.00. Following a project update, moved by Miller, and seconded by Tomasek, to approve the pay requests as presented. Roll call. Voting "aye" were Salem, Bennett, Tomasek, Miller, Fagot. Motion

carried.

PLANNING SESSION:

Pepplitsch proposed scheduling a planning session for Saturday, June 26, 2010. He noted that this session would be a mobile workshop to tour current project job sites. Moved by Miller, seconded by Tomasek, to set a Planning Session for Saturday, June 26, 2010, at 8 a.m. Roll call. Voting "aye" were Salem, Bennett, Tomasek, Miller, Fagot. Motion carried.

PAY REQUEST:

Pepplitsch presented Pay Request #4 for the Municipal Building Renovation project from Paulsen Inc. in the amount of \$69,840.00. Following a project update, moved by Bennett, seconded by Miller, to approve the pay request as presented. Roll call. Voting "aye" were Tomasek, Salem, Miller, Bennett, Fagot. Motion carried.

ROUNDTABLE:

Pepplitsch announced that an Energy Efficiency Block Grant application in the amount of \$250,000.00 for roof repairs and insulation for the Dawson County Opportunity Center was approved for funding. He also reported on recent storm damage and gave updates on several current projects.

Weinhold noted that he will be absent from the June 22, 2010 Council meeting. Miller noted that she may also be absent from that meeting.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
