CED SECOND ADDITION:

Mayor Fagot opened a Public Hearing to consider annexation of the CED Second Addition into the corporate limits of the City of Lexington. Pepplitsch reviewed development plans for the area and noted that annexation was requested during the subdivision process. Following discussion, the public hearing was closed.

Mayor Fagot opened a Public Hearing to consider a rezoning application to change zoning from A-2 Urban Reserve to R-2 Residential District for the CED Second Addition. Pepplitsch noted that this zoning designation would allow for single family and duplex units, and be consistent with abutting land use. Following discussion, the public hearing was closed.

Pepplitsch presented a subdivision agreement for the CED Second Addition. He noted that this agreement mirrors the CED Addition agreement and highlighted the financing of infrastructure to support housing development. He also noted an error in the subdivision name in the proposed agreement.

Resolution No. 2010-12 was presented for consideration. Moved by Salem, seconded by Bennett, to approve Resolution No. 2010-12 as presented. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

RESOLUTION NO. 2010-12 CED SECOND ADDITION

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

That CED SECOND ADDITION, to the City of Lexington, Nebraska, shall be included within the corporate limits of the City and become a part of the City for all purposes whatsoever and the inhabitants of the Addition shall be entitled to all the rights and privileges and be subject to all the laws, ordinances, rules and regulations of the City.

Ordinance No. 2282, entitled "AN ORDINANCE TO REZONE CED SECOND ADDITION TO THE CITY OF LEXINGTON, FROM A-2 URBAN RESERVE, TO R-2 RESIDENTIAL DISTRICT; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM", was presented for Council consideration. Moved by Salem, seconded by Tomasek, to approve Ordinance No. 2282 on first reading. Roll call. Voting "aye" were Bennett, Tomasek, Salem, Fagot. Motion carried.

Moved by Salem, seconded by Bennett, to approve the Subdivision Agreement with noted amendment to the name of the subdivision in the agreement and to authorize the City Manager to execute. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

NW 3rd INFRASTRUCTURE: Dana Daniels presented plans and specification for the Northwest Third Addition Infrastructure Improvements project. He outlined the services to include concrete paying and sanitary sewer in the project, with the water line to be installed by city crews. Pepplitsch reported that this project is being done in conjunction with the New Neighborhood grant project. Following discussion, moved by Salem, seconded by Bennett, to approve the plans and specifications for the NW Third Infrastructure Improvements and authorize the solicitation of bids. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

INTERLOCAL AGREEMENT: Pepplitsch presented an interlocal agreement with Dawson County for GIS web hosting services. He reported that this will be a cooperative effort by both entities to integrate county and city public records that will be available in a web based format. He and Brecks noted that new aerial imagery has recently been received. Following discussion, moved by Tomasek, seconded by Salem, to authorize the mayor to execute the interlocal agreement with Dawson County as presented. Roll call. Voting "aye" were Bennett, Salem, Tomasek, Fagot. Motion carried.

FINANCIAL REPORT:

Pepplitsch presented the financial report for April 2010. discussion, moved by Salem, seconded by Bennett, to approve the financial report as presented. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

ROUNDTABLE:

Pepplitsch gave updates on several current projects. He also proposed a date for a Council planning session on June 26th; which would be a mobile session to tour current and future project sites.

Burnside noted that a kickoff meeting with the website design firm is scheduled for June 3; and he is conducting a photo contest available for area residents for photos to be included on the new website.

Salem noted the increased pedestrian traffic on the trail abutting Hwy 283.

ADJOURNMENT:

There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
