ORDINANCE:

Ordinance No. 2299 entitled "AN ORDINANCE TO AMEND SECTION 16-45 OF THE LEXINGTON CITY CODE; TO ALLOW PARKING ON TAFT STREET FROM 5TH STREET TO 13TH STREET; TO REPEAL ORIGINAL SECTION 16-45 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented on second reading. No public comments had been received regarding the ordinance. Following discussion, moved by Salem, seconded by Tomasek, to suspend the rules regarding the reading of an ordinance on three separate readings. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Salem, Fagot. Motion carried.

Ordinance No. 2299 was presented on final reading. Moved by Salem, seconded by Miller, to approve Ordinance No. 2299 as presented on final reading. Roll call. Voting "aye" were Bennett, Tomasek, Miller, Salem, Fagot. Motion carried.

ORDINANCE: Ordinance No. 2300 entitled "AN ORDINANCE TO ESTABLISH BUSINESS LICENSES AND REGULATIONS AS CHAPTER 13 OF THE LEXINGTON CITY CODE; PROVIDE REGULATION OF VENDORS; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented on second reading. Pepplitsch highlighted the changes to the current street vendor ordinance, including additions, exemptions, prohibited conduct, prohibited areas along Plum Creek Parkway, and penalties for violating nuisance codes, as well as placing the ordinance in Chapter 13 of the City Code. He explained that this chapter is intended to include other business licenses.

Darrell Bliven and Jim Lauby, Central Nebraska Wholesale Fireworks, appeared before the Council to request a variance for a fireworks stand located on a property along the Highway 283 corridor. Discussion included property maintenance at the proposed site, access to the property, state regulations

	regarding licensing of firework stands, economic development in the area, and a buffer area along Highway 283. Following discussion, Council requested firework stands to be included as an exemption of the vendor requirements.
	Council directed Staff to identify various buffer zones along the corridor for discussion at the next city council meeting. No action was taken on the ordinance.
PAY REQUEST:	Pepplitsch reviewed Pay Request #3 from Central Contracting for the Opportunity Center Phase 3 project in the amount of \$165,196.80. Following discussion, moved by Tomasek, seconded by Bennett, to approve the pay request as presented. Roll call. Voting 'aye'' were Miller, Salem, Bennett, Tomasek, Fagot. Motion carried.

ADJOURNMENT:	There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
