Mayor Fagot welcomed Lexington High School students Elvia Tobias and Stephanie Jimenez who were in attendance as part of their Broadcast and Journalism class.

PUBLIC HEARING:

Mayor Fagot opened a public hearing for Council to sit as a Board of Equalization to consider assessments for delinquent property maintenance abatement fees. Pepplitsch explained these are unpaid fees intended to be filed as a liens against properties. Gerardo Ortiz appeared as a property owner and disputed a billing. Bill Brecks explained the property maintenance abatement notice and billing process, stating that every attempt is made to contact the property owner on file and to work with owners on abatements. Pepplitsch noted that this particular file can be reviewed with Staff. Following discussion, the public hearing was closed.

An Ordinance entitled "AN ORDINANCE TO ASSESS THE COST OF PROPERTY MAINTENANCE AGAINST CERTAIN PROPERTIES; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented for First reading. Moved by Salem, seconded by Bennett, to approve Ordinance No. 2305 on first reading. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

STORM WATER MGMT:

Bill Brecks reviewed a new five year Storm Water Management Plan. He noted that previous plan generally focused on public education. The new plan will include public education and interaction, as well as focus on construction site regulation. Following discussion for public information, no necessary action was taken or required.

GRANT APPLICATION:

Pepplitsch reviewed the details of a grant application to the Economic Development Administration (EDA) for infrastructure improvements in the Southeast Business Park. Following discussion of the grant application and the proposed infrastructure improvements, moved by Salem seconded by Tomasek to authorize the City Manager to execute all necessary documentation related to the submission of the EDA grant application as presented. Roll call. Voting "aye" were Bennett, Tomasek, Salem, Fagot. Motion carried.

BUDGET HEARING:

Mayor Fagot opened a public hearing to discuss the proposed 2011-2012 fiscal year budget. Council discussed the City of Lexington 2012 fiscal year budget, specifically including funding in the form of a cash match of \$750,000 for an Economic Development Administration (EDA) grant for infrastructure development in the Southeast Business Park. The public hearing was closed. Moved by Salem, seconded by Bennett to authorize the cash match expenditure of \$750,000 for the EDA grant application in the 2012 fiscal year budget. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

RESTRICTED FUNDS:

Pepplitsch recommended the Council increase the base of restricted funds authority by an additional 1%. Following discussion, moved by Tomasek, seconded by Salem, to increase the base of restricted funds by an additional 1% for FY 2012. Roll call. Voting "aye" were Bennett, Salem, Tomasek, Fagot. Motion carried.

TAX REQUEST HEARING:

Mayor Fagot opened a public hearing to discuss setting the FY 2012 final tax request at a different amount than the prior year request. Following discussion, the public hearing was closed. Resolution No. 2011-32 was read before Council. Moved by Salem, seconded by Bennett, to approve Resolution No. 2011-32 as presented. Roll call. Voting "aye" were Tomasek, Bennett, Salem, Fagot. Motion carried.

RESOLUTION NO. 2011-32

A RESOLUTION SETTING THE PROPERTY TAX REQUEST FOR FISCAL YEAR 2011-2012 AT A DIFFERENT AMOUNT THAN THE PRIOR YEAR REQUEST.

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the city of Lexington passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interests of the Municipality that the property tax request for the current year be a different amount than the property tax request for the prior year.

NOW, THEREFORE, the Governing Body of the city of Lexington by a majority vote resolves that:

- 1. The 2011-2012 property tax request is set at \$930,425.49.
- 2. A copy of this resolution shall be certified and forwarded to the County Clerk prior to October 13, 2011.

Resolution No. 2011-33 was presented. Following discussion, moved by Bennett, seconded by Tomasek, to approve Resolution No. 2011-33 as presented. Roll call. Voting "aye" were Salem, Bennett, Tomasek, Fagot. Motion carried.

RESOLUTION NO. 2011-33

WHEREAS, Section 22-6 of the Lexington City Code authorizes the City Council to establish by resolution the charges and fees for collection of refuse and garbage, and;

WHEREAS, Lexington City Code Section 8-19, authorizes the City Council to establish by Resolution a schedule of rates and charges for electric service, and; WHEREAS, an increase in operating expenses justifies an increase in existing rates.

BE IT THEREFORE RESOLVED, that effective October 1, 2011, the charge to be collected for residential garbage pickup within the City of Lexington shall be \$14.00 per month, plus an administrative charge of \$1.00, for a total of \$15.00 per month.

BE IT FURTHER RESOLVED, that effective October 1, 2011, the charge for residential garbage pickup customers who are single and 65 years of age or older shall be \$12.00, plus administrative charge of \$1.00, for a total of \$13.00 per month.

BE IT FURTHER RESOLVED, that effective October 1, 2011, an Automated Meter Reading fee for all electric utility customers shall be \$1.00 per meter per month.
