WHEREAS, there are federal funds available under Section 5311 of the Federal Transit Act and for the Nebraska Public Transportation Assistance Program, and

WHEREAS, the Community Action Partnership of Mid Nebraska-RYDE Transit desires to apply for said funds to provide public transportation in Dawson County.

NOW THEREFORE, BE IT RESOLVED; the City of Lexington, Nebraska hereby instructs the Community Action Partnership of Mid Nebraska-RYDE Transit to apply for said funds.

Said funds are to be used for the Community Action Partnership of Mid Nebraska – RYDE Transit transportation operations in the FY 2014-2015 Application for Public Transportation Assistance.

Passed and approved this 8th day of April, 2014.

PUBLIC HEARING:Deb Jensen, Dawson Area Development, presented the process for the Phase
2 Year 1 application to the Comprehensive Investment and Stabilization
(CIS) Program for discussion. Pepplitsch indicated that staff is proposing
applying for CIS funds for infrastructure improvements along 5th and 6th
Streets from Grant to Lincoln Streets. A formal public hearing will be held
on Tuesday, April 22, 2014, for consideration of the application. No action
was taken.

SIGN REGULATIONS: Ordinance No. 2344 entitled "AN ORDINANCE TO AMEND SECTIONS 109-01 THROUGH 109-13 OF THE LEXINGTON CITY CODE; TO REPEAL ORIGINAL SECTIONS 109-01 THROUGH 109-13 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented. Pepplitsch noted the amendments are intended to update and reorganize

He also announced that Lexington was the recipient of the Daniel Burnham Award from the Nebraska Chapter of American Planning Association for the recently completed Comprehensive Plan-2030.
ADJOURNMENT:	There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
