BD OF EQUALIZATION:

Mayor Fagot opened a public hearing for Council to sit as a Board of Equalization to consider assessments for delinquent property maintenance abatement fees. Pepplitsch noted that due process has been followed in notifying property owners regarding the pending assessments. As there were no public comments received, the public hearing was closed. Ordinance No. 2338 entitled "AN ORDINANCE TO ASSESS THE COST OF PROPERTY MAINTENANCE AGAINST CERTAIN PROPERTIES; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented. Moved by Salem, seconded by Roberts, to suspend the rules regarding reading of ordinances on three separate occasions. Roll call. Voting "aye" were Miller, Vivas, Roberts, Salem, Fagot. Motion carried.

Ordinance No. 2338 was presented on Final reading. Moved by Salem, seconded by Miller, to approve Ordinance No. 2338 on final reading. Roll call. Voting "aye" were Vivas, Roberts, Miller, Salem, Fagot. Motion carried.

- AMBULANCE BIDS: Pepplitsch reviewed bids received for a new ambulance unit. Doug Glaze, LVFD Rescue Chief, stated that after review of the bids per specification, the LVFD recommends award of a contract to FYR-TEK for the Type I Horton unit as bid. Following discussion, moved by Miller, seconded by Vivas, to accept the bids, award a contract to FYR-TEK, and authorize the City Manager to execute any necessary documents. Roll call. Voting "aye" were Salem, Roberts, Vivas, Miller, Fagot. Motion carried.
- **ZONING ORDINANCE:** Mayor Fagot opened a public hearing to consider Ordinance No. 2339, containing amended zoning regulations for the City of Lexington. Following Council and staff review of the proposed regulations and discussion, the public hearing was closed. Ordinance No. 2339, entitled "Zoning Ordinance of the City of Lexington, Nebraska" was presented. Moved by Miller, seconded by Salem, to approve Ordinance No. 2339 on first reading. Roll call. Voting "aye" were Vivas, Roberts, Salem, Miller, Fagot. Motion carried.
- **PAY REQUEST:** Pepplitsch reviewed Pay Request #10 from BRB Contractors Inc for the WWTP Improvement project in the amount of \$308,709.09. Following a project update, moved by Salem, seconded by Roberts, to approve the pay request as presented. Roll call. Voting "aye" were Miller, Vivas, Roberts, Salem, Fagot. Motion carried.
- **ROUNDTABLE DISCUSSION:** Pepplitsch reminded Council and Staff of the Work Session scheduled for Saturday, January 18.

Baruth recognized Dean Erickson as the new reporter for the Lexington Clipper-Herald who was then welcomed by Council and Staff.

ADJOURNMENT: There being no further business to come before the Council, Mayor Fagot declared the meeting adjourned.
