A Work Session of the Lexington City Council was held Saturday, August 4, 2018, at the Lexington City Hall, located at 406 East 7th Street, Lexington, Nebraska at 8:00 a.m. Members of the Council present were John Fagot, John Salem, Steve Smith and Jeremy Roberts. Dora Vivas was excused. City Officials present were City Manager Joe Peplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, and Finance Director Barb Hodges.

HIKE/BIKE TRAIL: The meeting was reconvened at 11:30 a.m. at the northwest corner of Adams and 20th Streets for Council and Staff to tour and discuss the Northwest Trail project.

ADJOURNMENT: There being no further business to come before Council, Mayor Fagot declared the meeting adjourned at 12:00 p.m.
