## CITY COUNCIL CITY OF LEXINGTON, NEBRASKA August 11, 2021

A Regular Meeting of the Lexington City Council was held Wednesday, August 11, 2021, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Salem, Steve Smith, and Jeremy Roberts. John Fagot and Dora Vivas were excused. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges, and City Clerk Pamela Baruth. The press was represented by Clipper-Herald.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEXINGTON AS HOLDER OF THE TAX INCREMENT DEVELOPMENT REVENUE BOND (HNB PROPERTIES REDEVELOPMENT PROJECT), SERIES 2017 A CONSENTING TO THE ALLOCATION OF CERTAIN REVENUES TO THE TAX INCREMENT DEVELOPMENT REVENUE BOND (HNB PROPERTIES REDEVELOPMENT PROJECT), SERIES 2017 B AND OTHER MATTERS.

WHEREAS, the City of Lexington, Nebraska (the "City") is the owner and holder of that certain TAX INCREMENT DEVELOPMENT REVENUE BOND (HNB PROPERTIES REDEVELOPMENT PROJECT), SERIES 2017 A and has received a request to approve a minor allocation of revenue change that will not impact the receipt of revenue on said bond;

# NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA AS FOLLOWS:

**Section 1.** The City of Lexington, Nebraska, hereby consents to the revised allocation of revenues as set forth in the Amended Redevelopment Contract between the Community Development Agency of the City and HNB Properties, LLC.

Section 2. This Resolution shall take effect as provided by law.
