A Regular Meeting of the Lexington City Council was held Tuesday, February 8, 2022, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, and Dora Vivas. Jeremy Roberts and Steve Smith were excused. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges, and City Clerk Pamela Baruth. PUBLIC HEARING: Mayor Fagot opened a public hearing to consider a liquor license application by Preet Hospitality DBA Thrifty's Gas & Liquor for property located at 201 East 6th Street. Pepplitsch reviewed the application and a few words were given by Prahladbhai Chaudhari who is purchasing the current business. There being no public comments, the public hearing was closed. Following discussion, moved by Salem, seconded by Vivas, to recommend approval of the liquor license application by Preet Hospitality DBA Thrifty's Gas & Liquor to the Nebraska Liquor Control Commission. Roll call. Voting "aye" were Vivas, Salem, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider the amendment of Redevelopment Area #1 in the City of Lexington NE and the declaration or re-declaration of said area as blighted and substandard. Pepplitsch reviewed the re-evaluation of Redevelopment Area #1, the suggested additions and deletions of land parcels, and the past and current blight and substandard conditions. There being no public comments, the public hearing was closed. Resolution No. 2022-03 was presented. Moved by Salem, seconded by Vivas, to approve Resolution No. 2022-03. Roll call. Voting "aye" were Vivas, Salem, Fagot. Motion carried.

RESOLUTION NO. 2022 - 03

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, APPROVING THE AMENDMENT OF REDEVELOPMENT AREA #1 OF THE CITY OF LEXINGTON, NEBRASKA, AND DECLARING OR REDECLARING SAID AREA TO BE BLIGHTED AND SUBSTANDARD, PURSUANT TO THE NEBRASKA COMMUNITY DEVELOPMENT LAW.

WHEREAS, on January 14, 2003, pursuant to Resolution No. 03-01, the City Council of the City of Lexington, Nebraska (the "City") declared an area of the City of Lexington, Nebraska to be blighted and substandard and in need of redevelopment, which area is identified as Redevelopment Area #1;

WHEREAS, the City desires to add one (1) parcel to Redevelopment Area #1 (the "New Parcel"), which is identified and legally described on Exhibit "A" attached hereto;

WHEREAS, the City desires to remove fifteen (15) parcels from Redevelopment Area #1 (the "Subject Parcels"), which are identified and legally described on <u>Exhibit "B"</u> attached hereto:

WHEREAS, the Lexington Planning Commission recommended that the City Council approve the amendment of Redevelopment Area #1 to add the New Parcel and to remove the Subject Parcels, as depicted on the map attached hereto as Exhibit "C" (the "Amendment"), pursuant to the Community Development Law, Neb. Rev. Stat. § 18-2101 et seq., as amended (the "Act");

WHEREAS, the Lexington Planning Commission also recommended that the City Council declare or re-declare Redevelopment Area #1, as amended by the Amendment (the "Revised Redevelopment Area #1"), blighted and substandard and in need of redevelopment, as defined in and pursuant to the Act;

WHEREAS, Hanna: Keelan Associates, P.C. ("Hanna: Keelan") prepared a Blight/Substandard Determination Study in December, 2002 for Redevelopment Area #1 (the "2002 Study"). A copy of the 2002 Study is on file with the City Clerk;

WHEREAS, Hanna: Keelan has prepared an analysis dated December 29, 2021 (the "2021 Analysis") on whether the Revised Redevelopment Area #1 would remain blighted and substandard, as documented in the 2002 Study. A copy of the 2021 Analysis is on file with the City Clerk;

WHEREAS, the Notice of Public Hearing relating to the question of whether the Amendment to Redevelopment Area #1 should approved, and the question of whether the Revised Redevelopment Area #1 should be declared or re-declared blighted and substandard and in need of redevelopment, was provided in conformity with Sections 18-2109 and 18-2115.01 of the Act; and

WHEREAS, the City Council has reviewed the Planning Commission's recommendations after review pursuant to Section 18-2109 of the Act and has duly considered all statements made and material submitted related to the submitted questions.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

- 1. That the Amendment to Redevelopment Area #1 is hereby approved pursuant to the Act.
- 2. That the Revised Redevelopment Area #1 is hereby declared or re-declared to be blighted and substandard and in need of redevelopment.
- 3. That the conditions set forth in the 2021 Analysis demonstrate sufficient evidence that the Revised Redevelopment Area #1 would remain a blighted and substandard area within the meaning of the Act.
- 4. That such substandard and blighted condition is beyond the remedy and control solely by regulatory process and the exercise of police power and cannot be dealt with effectively by the ordinary operations of private enterprise without the aids provided by the Act, and the elimination of said substandard and blighted condition under the authority of the Act is hereby found to be a public purpose declared to be in the public interest.
- 5. That it is hereby found and determined that said area is an eligible site for a redevelopment project under the provisions of the Act.
- 6. That any Resolution passed and approved prior to the passage, approval and publication of this Resolution which is in conflict with the terms and provision of this Resolution is/are hereby repealed.

PASSED AND APPROVED this 8th day of February, 2022.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider the final plat of the Auto Haus Second Subdivision. Pepplitsch reviewed the plat and the proposed subdivision agreement. There being no public comments, the public hearing was closed. Resolution No. 2021-24 was presented. Moved by Vivas, seconded by Salem, to approve Resolution No. 2021-24. Roll call. Voting "aye" were Salem, Vivas, Fagot. Motion carried.

Moved by Salem, seconded by Vivas, to approve the subdivision agreement for Auto Haus Second Subdivision as presented. Roll call. Voting "aye" were Vivas, Salem, Fagot. Motion carried.

RESOLUTION NO. 2021 - 24

AUTO HAUS SECOND SUBDIVISION

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

The plat of AUTO HAUS SECOND SUBDIVISION, a Replat of Lot 1, Auto Haus Addition, an Addition to the City of Lexington, Dawson County, Nebraska, duly made out, acknowledged and certified, and the same hereby is approved, accepted and ordered filed and recorded in the office of the Register of Deeds of Dawson County, Nebraska.

PASSED AND APPROVED this 8th day of February, 2022.

AUDIT REPORT: Barb Hodges, Finance Director, presented the 2021 Audit Report, stating an unqualified opinion was issued. Following her report, moved by Vivas, seconded by Salem, to accept the 2021 Audit Report. Roll call. Voting "aye" were Salem, Vivas, Fagot. Motion carried.

ACTION PLAN: Pepplitsch presented a final draft of the 2022 Development Action Plan. Following discussion, moved by Vivas, seconded by Salem, to approve the 2022 Development Action Plan as presented. Roll call. Voting "aye" were Salem, Vivas, Fagot. Motion carried.

COMMUNITY TREE PLAN: Burnside presented a final draft of the Emerald Ash Borer Readiness and Response Plan. He explained that this plan is a requirement for grant funds through The Arbor Day Foundation in anticipation of inevitable ash tree problems within the city's tree inventory. Following his review, moved by Salem, seconded by Vivas, to approve the Emerald Ash Borer Readiness and Response Plan as presented. Roll call. Voting "aye" were Vivas, Salem, Fagot. Motion carried.

APPOINTMENT: Moved by Salem, seconded by Vivas, to appoint Brad Worthing to fulfill the remaining term held by Riley Gruntorad on the Lexington Airport Authority. Roll call. Voting "aye" were Vivas, Salem, Fagot. Motion carried.

PAY REQUEST: Pepplitsch reviewed Pay Request #5 from Walters-Morgan Construction for the 2021 Wastewater Facility Improvements project in the amount of \$261,032.02. Following discussion, moved by Vivas, seconded by Salem, to approve the pay request as presented. Roll call. Voting "aye" were Salem, Vivas, Fagot. Motion carried.

ROUNDTABLE: Pepplitsch gave an update on current projects. Salem commented on a recent open house by Lacy Construction and positive comments received on Lexington's readiness for future housing development.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
