A Regular Meeting of the Lexington City Council was held Tuesday, October 25, 2022, at the Lexington City Hall, 406 E. 7th Street, Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith, and Jeremy Roberts. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges and City Clerk Pamela Baruth. The press was represented by The Clipper-Herald.

NOTICE: Notice of the meeting was given in advance, thereof by publication in the Lexington Clipper-Herald, the designated method for giving notice, as shown by the Affidavit of Publication attached to these Minutes. Notice of this meeting was simultaneously given to the mayor and all members of the Council, and a copy of their Acknowledgment of Receipt of Notice and the Agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this Meeting. CALL TO ORDER: The meeting was called to order by Mayor John Fagot. Fagot informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington City Hall, 406 E. 7th Street, Lexington, Nebraska.

FINANCIAL REPORT: Moved by Roberts, seconded by Salem, to accept the financial report for September 2022 as presented. Roll call. Voting "aye" were Vivas, Smith, Salem, Roberts, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider a Liquor License application by Wilkinson Development Inc. dba Fat Dogs Lexington for a Class D liquor license. Nathan Push, Wilkinson Development, explained the company is restructuring the business entities for ease and continuity. There were no public comments and the public hearing was closed. Following discussion, moved by Salem, seconded by Roberts, to recommend approval to the Liquor Control Commission of the application for Wilkinson Development Inc. dba Fat Dogs Lexington as presented. Roll call. Voting "aye" were Vivas, Smith, Roberts, Salem, Fagot. Motion carried.

PROJECT BIDS: Pepplitsch reviewed bids received for the Standby Power Improvements project. He noted that the scope of the project was scaled down due to high cost of the equipment. He reviewed Change Order #1 and final bid tabulation. Following discussion, moved by Roberts, seconded by Smith, to accept the bids and award a contract to Red Fern Electric, with the approval of Change Order #1 as presented. Roll call. Voting "aye" were Vivas, Salem, Smith, Roberts, Fagot. Motion carried.

ROUNDTABLE DISCUSSION: Pepplitsch gave an update of current and future projects. Baruth stated she would be absent from the November 8, 2022, meeting.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
