CITY COUNCIL CITY OF LEXINGTON, NEBRASKA September 24, 2024

A Regular Meeting of the Lexington City Council was held Tuesday, September 24, 2024, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Steve Smith, and Jeremy Roberts. Dora Vivas was absent. FINANCIAL REPORT: Moved by Smith, seconded by Roberts, to accept the financial report for August 2024 as presented. Roll call. Voting "aye" were Salem, Roberts, Smith, Fagot. Motion carried.

PUBLIC COMMENTS: Jennifer Norton, Library Director, appeared to thank John Fagot, John Salem, and Joe Pepplitsch for speaking with El Camino's Leadership Development class recently. She also stated her appreciation to Council and Staff for the library budget. Abiba Alice Shomari appeared to report on the recent revival at the fairgrounds and thank the Council for their support.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider a liquor license application by Pinedo Enterprises LLC dba Toro Tom's Sports Bar & Grill for property located at 405 East Pacific. Alejandro Pinedo, owner of Pinedo Enterprises, LLC, appeared before Council to outline the plans for a sports bar and grill. There were no public comments, and the public hearing was closed. Following discussion, moved by Roberts, seconded by Salem, to recommend approval of a liquor license application for Toro Tom's Sports Bar & Grill. Roll call. Voting "aye" were Smith, Salem, Roberts, Fagot. Motion carried.

RESTRICTED FUNDS: Pepplitsch reviewed the option to increase the allowable restricted funds budget authority. Following discussion, moved by Salem, seconded by Smith, to increase the base of restricted funds by an additional 1% for FY 2024-2025 budget. Roll call. Voting "aye" were Roberts, Smith, Salem, Fagot. Motion carried.

RESOLUTION NO. 2024-21

A RESOLUTION SETTING THE PROPERTY TAX REQUEST FOR FISCAL YEAR 2024-2025

WHEREAS, Nebraska Revised Statute 77-1632 and 77-1633 provides that the Governing Body of the City of Lexington passes by a majority vote a resolution setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Governing Body of the City of Lexington resolves that:

- 1. The 2024-2025 property tax request be set at \$1,796,504.17.
- 2. The total assessed value of property differs from last year's total assessed value by 6.35%.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$0.306166 per \$100 of assessed value.
- 4. The City of Lexington proposes to adopt a property tax request that will cause its tax rate to be \$0.321682 per \$100 of assessed value.
- 5. Based on the proposed tax request and changes in other revenue, the total operating budget of the City of Lexington will <u>decrease</u> last year's by 2.71 percent.

6. A copy of this resolution shall be certified and forwarded to the Dawson County Clerk on or before October 15, 2024.
