CITY COUNCIL CITY OF LEXINGTON, NEBRASKA August 26, 2025

A Regular Meeting of the Lexington City Council was held Tuesday, August 26, 2025, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, and Jeremy Roberts. Jared Jacob was absent. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, Finance Director Derek Haines, Community Development Director Bill Brecks, and City Clerk Pamela Baruth. The press was represented by the Clipper-Herald.

CALL TO ORDER: The meeting was called to order by Mayor Fagot. Fagot informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington City Hall, 406 E. 7th Street, Lexington, Nebraska.

MINUTES – REGULAR MEETING 8-12-2025: Minutes of the Regular meeting held Tuesday, August 12, 2025, were presented. Moved by Vivas, seconded by Salem, to approve the minutes as presented. Roll call. Voting "aye" were Roberts, Salem, Vivas, Fagot. Motion carried.

FINANCIAL REPORT: Moved by Roberts, seconded by Vivas, to accept the financial report for July 2025 as presented. Roll call. Voting "aye" were Salem, Vivas, Roberts, Fagot. Motion carried.

ORDINANCE: Ordinance No. 2477 entitled "AN ORDINANCE TO AMEND SECTION 2-26 OF THE LEXINGTON CITY CODE; TO REPEAL ORIGINAL SECTIONS 2-26, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN ELECTRONIC FORM" was presented. Pepplitsch reviewed a recent statutory change that allows the council to convene as a board of adjustment in cities of the first class in Nebraska. Following discussion, moved by Salem, seconded by Vivas, to approve Ordinance No. 2477 on first reading. Roll call. Voting "aye" were Roberts, Vivas, Salem, Fagot. Motion carried.

ROUNDTABLE: Pepplitsch gave a timeline of the budget hearing process and copies of the proposed budget to council members. He also reminded the council of an open house on September 2, 2025, regarding Next Generation Nuclear conversations.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
